Assessment

Background

The G20 plays a leading role in contributing to the implementation of the United Nations' 2030 Agenda for Sustainable Development, including the Sustainable Development Goals (SDGs) and the Addis Ababa Action Agenda on Financing for Development. The G20 leaders first recognized the need to explore ways to restore emerging and developing countries' access to credit and resume private capital flows that are critical for sustainable growth and development at the 2008 Washington Summit. The 2015 Antalya Summit was the first time SDGs were mentioned by the G20 and commitments were laid out to align with the SDGs and Addis Ababa Action Agenda.³

At the 2009 Pittsburgh Summit, the G20 leaders had launched the Framework for Strong, Sustainable and Balanced Growth to set out the G20's economic agenda and assess future progress. They recognized the importance of including developing countries in the efforts to narrow the development gap.⁴

At the 2010 Toronto Summit, the G20 leaders created the G20 Development Working Group to lead the implementation of the G20's development goals and to help secure strong, sustainable and balanced growth.⁵

At the 2010 Seoul Summit, the leaders pledged to continue their coordinated efforts and act together to generate strong, sustainable and balanced growth and agreed to develop a common view to meet these new challenges and a path to strong, sustainable and balanced growth beyond the 2008-9 global economic crisis.⁶ They launched the Seoul Development Consensus. The Seoul Action Plan emerged as the first attempt to concentrate efforts on overcoming significant barriers to inclusive, sustainable, and resilient growth in developing countries, particularly low-income countries. The primary focus areas identified by G20 leaders included infrastructure, human resources development, trade, private investment, job creation, food security, growth with resilience, financial inclusion, domestic resource mobilization, and knowledge sharing.⁷ Several of these subjects were later covered by the 'SDGs.

At the 2012 Los Cabos Summit, G20 leaders reiterated the importance of promoting sustainable development and identifying new actions to enhance collaboration and find a collective and targeted solution to pressing development challenges.⁸

At the 2013 St. Petersburg Summit, G20 leaders reaffirmed their commitment to shared growth. They emphasised the need to enhance the inclusion of developing countries in the implementation of sustainable development goals with focus on economic growth, environmental protection and social inclusion.⁹

The 2015 Antalya Summit marked a significant milestone as G20 leaders committed to developing an action plan aligning the G20's work with the 2030 Agenda for Sustainable Development, which had been launched at the UN in September 2015. They reiterated their pledge to ensuring their actions contributed to inclusive and sustainable growth, including in low income developing countries.¹⁰ The G20 National Remittance Plans developed in 2015 included concrete actions towards the leaders' commitment to align with the SDGs and Addis Ababa Action Agenda.¹¹

At the 2016 Hangzhou Summit, G20 leaders pledged to enhance policy coherence on sustainable development and reaffirmed their commitment to further align their work with the universal implementation of the 2030 Agenda for Sustainable Development based on the comparative advantage and the added value of the G20 and in accordance with their national circumstances, while acknowledging that the global follow-up and review of the 2030 Agenda is a UN-led process. The G20 leaders endorsed the G20 Action Plan on the 2030 Agenda for Sustainable Development and committed to further align the G20's work with the 2030 Agenda.

At the 2017 Hamburg Summit, G20 leaders reaffirmed the commitment to collaborate closely in facilitating well-balanced and economically viable long- term strategies in order to transform and

enhance their economies and energy systems consistent with the 2030 Agenda for Sustainable Development.¹² The leaders also committed to further align their actions with the 2030 Agenda for Sustainable Development, domestically and internationally, including in support of developing countries and the provision of public goods. The Hamburg Update was a first step towards putting the G20 Action Plan into practice and making the collective and concrete G20 actions more visible.¹³

At the 2018 Buenos Aires Summit, G20 leaders reaffirmed their commitment to leading the transformation towards sustainable development and support the 2030 Agenda as the framework for advancing this goal and highlight collective and concrete G20 actions based on consensus and dialogue towards implementing the G20 Action Plan and contributing to the 2030 Agenda for Sustainable Development.¹⁴

At the 2019 Osaka Summit, G20 leaders committed to further lead efforts to foster development and address other global challenges to pave the way towards an inclusive and sustainable world as envisioned in the 2030 Agenda for Sustainable Development.¹⁵

At the 2020 Riyadh Summit, G20 leaders endorsed the Financing for Sustainable Development Framework, emphasizing the G20's leading role in the timely implementation of the 2030 Agenda and the Addis Ababa Action Agenda.¹⁶

At the 2021 Rome Summit, G20 leaders reaffirmed their commitment to a global response to accelerate progress on the implementation of the SDGs. The leaders committed to strengthen their actions to implement the G20 Action Plan on the 2030 Agenda and recognised the importance of SDG localization.¹⁷

At the 2022 Bali Summit, aligned with the Indonesian G20 Presidency theme, "Recover Together, Recover Stronger," G20 leaders pledged coordinated actions for sustainable development. They asked the Multilateral Development Banks to bring forward actions to mobilize and provide additional financing within their mandates, to support achievement of the SDGs including through sustainable development and infrastructure investments, and responding to global challenges. They highlighted their intention to demonstrate leadership and take collective actions to implement the 2030 Agenda for Sustainable Development and accelerate the achievement of the SDGs by 2030.¹⁸

Commitment Features

At the 2022 New Delhi Summit, leaders committed to "take collective action for effective and timely implementation of the G20 2023 Action Plan to Accelerate Progress on the SDGs, including its High-Level Principles."¹⁹

Definitions and Concepts

The High-Level Principles are summarized as follows²⁰:

The G20 should put sustainable development at the centre of the international cooperation agenda and leave no one behind, while, reaffirming the Addis Ababa Action Agenda, the UN Framework Convention on Climate Change (UNFCCC) and the Paris Agreement, the Convention on Biological Diversity (CBD) and the Kunming-Montreal Global Biodiversity Framework (KMGBF), the UN Convention to Combat Desertification (UNCCD), and the Sendai Framework for Disaster Risk Reduction, and supporting developing countries, least developed countries (LDCs) and small island development states (SIDS).

The G20 should continue to support and promote the creation of an enabling environment for sustainable development for all countries, especially for developing countries and for the provision of Global Public Goods.

The G20 commits to promote digital transformation; gender equality and empowerment of women; and implementation of sustainable, inclusive and just transitions globally while leaving no one behind, such as through transfer of technology in line with WTO rules, technology deployment, promoting access to finance from all sources, and capacity building. This includes taking concrete actions to reduce job, education, food and energy access, gender and other inequalities.

The G20 commits to making poverty alleviation a key priority in the implementation of the 2030 Agenda, and strengthening international cooperation in this regard, through G20 concrete and collective actions addressing structural vulnerabilities and imbalances, especially those faced by developing countries, and building a shared understanding of the multidimensional nature of vulnerability in partnership with the UN system.

The G20 commits to averting, minimizing and addressing loss and damage associated with the adverse effects of climate change, including via strengthening policy strategies and governance of comprehensive risk management including disaster risk reduction, displacement and non-economic losses. We welcome the establishment of the G20 Working Group on Disaster Risk Reduction during the Indian Presidency.

The G20 emphasizes the interlinkages between implementation of the 2030 Agenda, the UNFCCC and the Paris Agreement, the CBD and the KMGBF with the view of realizing the 2050 Vision of "Living in harmony with Nature," the UNCCD, and the Addis Ababa Action Agenda through an integrated and balanced approach, while taking into account national circumstances of developing countries and enhancing international cooperation and partnerships to mobilise adequate financing from all sources, innovative solutions and technologies, technology dissemination and capacity building.

The G20 calls upon the developed countries to fully deliver on their respective commitments on official development assistance that complement and encourage development financing from all other sources including domestic and private sources. G20 reaffirms the importance of promoting development finance respecting the applicable finance related principles, while noting the importance of transparency and mutual accountability. The G20 will also promote individual and collective actions for pursuing strategic and targeted national policies and support. The G20 will continue its work to drive sustainable investments in sustainable development taking into account national development plans including through work of G20 Sustainable Finance Working Group.

The G20 recognizes the key role of international financial institutions (IFIs), including the multilateral development banks (MDBs) for providing and mobilizing development financing, knowledge support, and for catalysing private investment and supporting the work of International Financial Architecture Working Group. In this regard, also recognizing the need for scaling up accessible financing for climate, nature and biodiversity.

The G20 recognizes sustainable, resilient, safe, accessible, affordable, inclusive and quality infrastructure and infrastructure investments as a key driver of economic prosperity in line with G20 Principles for Quality Infrastructure Investment and the G20 Guidelines on Quality Infrastructure for Regional Connectivity. We would promote collective actions for encouraging IFIs, including MDBs, and development financial institutions (DFIs) to support developing countries to scale-up and accelerate infrastructure investment including through mobilising public and private investments, providing knowledge and capacity building support and facilitating last mile connectivity.

The G20 stresses the need to urgently promote collective actions to support inclusive growth and sustainable development models that take into account priorities, needs, vulnerabilities and different national circumstances of developing countries. It is vital to respect each country's policy space and leadership to implement policies for poverty eradication and sustainable development, while remaining consistent with relevant international rules and commitments. The G20 also recognizes the role of local and regional governments, and other local actors, in a whole of society approach, to achieve the SDGs.

The G20 stresses that achievement of the SDGs needs to be accelerated across all countries, including through provision of global public goods, and any spill overs in this process need to be carefully addressed. Further, the G20 would make efforts to tailor its contribution to the 2030 Agenda taking into account the multi-dimensionality and non-linearity of the development process.

The G20 will demonstrate leadership and take collective actions to implement the 2030 Agenda for Sustainable Development and accelerate the achievement of the SDGs by 2030 and address developmental challenges by reinvigorating a more inclusive multilateralism and reform aimed at implementing the 2030 Agenda.

The G20 will continue to strengthen G20 efforts including through supporting the work of relevant G20 work streams and reiterate our commitment to step up our efforts to implement the Common Framework for Debt Treatment beyond the Debt Service Suspension Initiative in a predictable, timely, orderly and coordinated manner.

The G20 will enhance its cooperation, coordination and partnerships with the United Nations, IFIs including the MDBs, non-G20 developing countries and across the G20 tracks to contribute to addressing the cross-cutting challenges being faced in the implementation of the 2030 Agenda. The G20 will aim to contribute to the United Nations Summit of the Future, High Level Political Forum for Sustainable Development, SDG Summit and other relevant processes.

"Effective" is understood to mean "operating in a way that produces the intended result. It does not mean any effort, especially thoughtless ones."²¹

"Timely" is understood to mean "something coming early or at the right time."22

"Implementation" is understood to mean "the process of making something active or effective."23

"Accelerate" is understood to mean "to hasten the progress or development of something"24

"Progress" is understood to mean "movement to an improved or more developed state"25

"G20 2023 Action Plan to Accelerate Progress on the SDGs (including its High-Level Principles)" refers to a multi – year living document from G20 members in which they commit to deliver on the 2023 Agenda through collective action and transformative transitions.²⁶ The High-Level Principles centre on development and the environment.

"To accelerate progress (on the SDGs)" is understood to mean initiatives taken by G20 governments and non-state actors with the intention of accelerating SDG implementation.²⁷ It can refer to a new action or an ongoing action that is being implemented at a faster pace in order to achieve one of more of the SDGs. The ongoing action that is accelerated can include the introduction of a new phase or a scaling up of the effort.

"Effective implementation" is understood as taking steps forward in the right direction.²⁸ While the commitment may be part of a longer -term initiative and actions on it may continue into the prolonged future, concrete steps need to be taken in the near future to be considered implantation.

"Timely implementation" is understood to mean taking steps in the right direction in the near future.²⁹ This should not, therefore, be interpreted to mean prolonged or delayed action.

General Interpretive Guidelines

The G20 2023 Action Plan to Accelerate Progress on the SDGs identifies the three overarching dimensions of the SDGs as a) economic, b) environmental and c) social. To achieve full compliance, the G20 members must strongly comply with most aspects of each of these three dimensions. The G20 members have also committed to leave no one behind, so for full compliance, inclusivity, equity and the prioritization of the most vulnerable countries and demographics is needed.³⁰ With six years remaining for the implementation of the 2030 Agenda, the commitment calls for timely actions. For the purposes of this report strong implementing action must be taken within the compliance period. For full compliance cooperative action, i.e. bilateral, plurilateral or multilateral, is also required whereas unilateral domestic action will receive a score of 0.

To determine compliance, the actions taken by the G20 members will be broken down into two types of actions 1) strong and 2) less than strong.

Strong actions are defined as tangible actions that can reasonably be interpreted to have a long-term effect, such as legislation, treaties, policies, funding, that are collective/cooperative, and that are centred on inclusivity of the most vulnerable countries/demographics.

Less than strong actions are include one-time awareness campaigns, verbal reiterations of support, attending meetings etc., that are not focused on inclusivity, and are not cooperative, i.e. are unilateral/domestic actions.

Examples of strong, inclusive action on across the three dimensions include collaborations between G20 members and/or international organizations and/or LDCs/SIDs to provide capacity building support; building climate resilient infrastructure; working to reform the international financial architecture and enhance macroeconomic policy cooperation to create accessible financing for developing countries; collaborating on supporting a just transition for workers; reducing the gender pay gap, etc.

Full compliance, or a score of +1, will be given to G20 members that take collective action for effective and timely implementation, across all three pillars of economic, social and environmental action, of the G20 2023 Action Plan to Accelerate Progress on the SDGs, including its High-Level Principles. G20 members must take strong action in each of all three overarching dimensions aligned with the High-Level Principals, and the actions are both inclusive and cooperative.

Partial compliance, or a score of 0 will be assigned to G20 members that have taken action in at least 50 per cent of the commitment dimensions. This could include less than strong action across all three pillars or strong action across one or two pillars

Non-compliance, or a score of -1, will be assigned if the G20 member has not taken collective action or has done less than 50% of the commitment criteria, for the effective and timely implementation of the G20 2023 Action Plan to Accelerate Progress on the SDGs, including its High-Level Principles in any of the dimensions.

0	The G20 member took action in least 50 per cent of the commitment's three pillars, such as less than strong action in all three pillars, strong action in one or two pillars, also taking into account the two criteria of cooperative action and inclusive action.

Argentina: +1

Argentina has fully complied with the commitment to take collective action for implementing the G20 2023 Action Plan to Accelerate Progress on the Sustainable Development Goals (SDGs), including its High-Level Principles.

On 14 December 2023, Foreign Minister Diana Mondino met with European Union Member State Ambassadors and diplomatic representatives.³¹ This multilateral engagement included a working meeting which entailed common agreements to deepen the common agenda on cooperation. Minister Mondino requested openness to enhance sustainable and durable trade development.

On 15 December 2023, the Secretary of Bioeconomy, Fernando Vilela met with representatives of the Inter-American Development Bank, Agustín Aguerre, Rural Development Specialist, Bruno Jacquet and General Manager of the Southern Cone Countries Department, Florencia Attademo.³² The objective was to gain a deeper understanding of the Argentinian bioeconomy and reaffirmed commitment to international agreements regarding technological sustainability.

On 28 December 2023, Minister Mondino met with Director General of the International Atomic Energy Agency, Rafael Mariano Grossi.³³ The meeting entailed discussions on the NUTEC Plastics Initiative in partnership with the Argentine Antarctic Program, which aims to address marine pollution. In addition, Minister Mondino and Grossi discussed the role of nuclear technology and energy under the Argentine nuclear programme, and its impact on promoting sustainable development.

On 3 January 2024, Bioeconomy Secretariat and Germany's Federal Ministry of Food and Agriculture installed the first pilot site for sustainable production.³⁴ This aim is to increase bilateral commitments to sustainable development in agriculture.

On 10 January 2024, Minister Mondino convened with Heads of United Nations Agency offices in Argentina.³⁵ The objective was to present main actions carried out under the United Nations Sustainable Development Cooperation Framework. Furthermore, it reaffirmed Argentina's commitment to their partnership with the United Nations and supporting sustainable development goals.

On 26 January 2024, Minister Mondino engaged in a bilateral conversation with the Republic of Azerbaijan's Minister of Foreign Affairs, Jeyhun Bayramov.³⁶ The dialogue included commitments to strengthen the bilateral partnership and support Argentina in undertaking climate issues and sustainable development.

On 9 February 2024, the Undersecretary of American Affairs of the Argentine Foreign Ministry, Mariano Vergara engaged in a bilateral meeting with the Republic of Paraguay to promote joint infrastructure projects.³⁷ The objective was to discuss strategies on increased connectivity, through the extension of logistics networks.

On 16 February 2024, Minister Mondino attended the Munich Security Conference in Munich, Germany.³⁸ In this multilateral dialogue, Minister Mondino reaffirmed the commitment of Argentina towards sustainable development goals.

On 17 February 2024, Minister Mondino engaged in a bilateral meeting with United States Special Envoy for Global Food Security, Cary Fowler.³⁹ This meeting consolidated Argentina's role as a global supplier and reaffirmed their commitment to Sustainable Development Goals through the discussion on sustainable livestock farming.

On 22 February 2024, President Javier Milei engaged in a bilateral meeting with United States Secretary of State, Antony Blinken.⁴⁰ This meeting consolidated efforts to deepen bilateral economic ties and reaffirmed commitments to promoting clean energy and transitions in trade sustainability.

On 22 February 2024, Minister Mondino, attended the first G20 Foreign Ministers' Meeting in Rio de Janeiro, Brazil.⁴¹ This multilateral engagement reinforced Argentina's commitment to national and international sustainable development through the establishment of a stabilization program.

On 25 February 2024, Argentina became a signatory to the finalized Investment Facilitation for Development Agreement at the 13th World Trade Organization Ministerial Conference.⁴² This multilateral agreement entails the relationship between foreign direct investment in promoting sustainable development.

On 27 February 2024, Undersecretary of Environment of the Ministry of the Interior, Ana Lamas and representative of the Environmental Transborder Movements Unit, Florencia Lanzillota joined the Global Women's Breakfast hosted by the International Union of Pure and Applied Chemistry.⁴³ This

meeting emphasized the significance of multilateral partnerships to encourage the sustainable management of organic pollutants and metals.

On 28 February 2024, Minister of Economy Luis Caputo attended the G20 Ministerial Meeting in São Paulo, Brazil.⁴⁴ Minister Caputo convened with other ministers to discuss financing for sustainable development.

On 29 February 2024, Minister Mondino engaged in bilateral dialogue with Director of the Americas Division of Human Rights Watch, Dr. Juanita Goebertus Estrada.⁴⁵ This meeting consolidated objectives to promote and protect human rights and collaborate within international organization frameworks.

On 1 March 2024, Undersecretary Lamas attended the sixth session of the United Nations Environment Assembly of the United Nations Environment Programme.⁴⁶ This multilateral meeting aims to encourage environmental multilateralism in the development of global environmental policies.

On 1 March 2024, the Government of Argentina announced the establishment of two new air routes that will connect Argentinian cities with regional-international cities.⁴⁷ The objective is to increase international connection and promote the development of economies through subsequent tourism objectives.

On 5 March 2024, President Javier Milei, Secretary Vilella, General Secretary of the Presidency, Karina Milei, Secretary of Industry and Productive Development, Juan Pazo, Presidential Spokesperson, Manuel Adorni and National Deputy, José Luis Espert were in attendance at Expoagro 2024.⁴⁸ This agrobioindustrial fair aims to highlight the agrobioindustrial exports and processes such as transformation of biomass, which contributes to environmentally sustainable processes and exports of food, bioinputs and bioproducts.

On 6 March 2024, Minister Mondino alongside Secretary Vilella and Secretary Pazo, led a multilateral delegation on the agro-bioindustrial industry.⁴⁹ The delegation of 45 international leaders reaffirmed Argentinian-international partnerships and conceptualized ideas for the advancement of technology in the industry.

On 18 March 2024, Argentina represented by United Nations Argentina in partnership with the United Nations Environment Programme attended Lollapalooza music festival to promote a recreational

proposal on environmental pollution and sustainability.⁵⁰ This initiative achieved 17 Sustainable Development objectives.

On 18 March 2024, Undersecretary Lamas met with representatives of the United Nations Development Programme (UNDP).⁵¹ This meeting entailed advisory strategies from the UNDP that Argentina can implement to continue the progress of SDGs.

On 21 March 2024, Minister Mondino met with Japan's Minister of Foreign Affairs, Kamikawa Yoko.⁵² This meeting reaffirmed commitments to Argentina's sustainable growth through development cooperation, as outlined in the Diplomatic Initiative Towards Latin America and the Caribbean. This included objectives to strengthen bilateral cooperation regarding sustainable development support.

On 26 March 2024, public and private representatives attended the Food and Agriculture Organization of the United Nations' Expert Group Meeting on Sustainable Development Goal 2.⁵³ The Co-coordinator ad interim of Civil Society and Indigenous Peoples' Mechanism Secretariat, Magdalena Ackerman and Senior Vice President of Sustainability Strategy and Partnerships at Danone, Corporate Affairs Director for Argentina, Facundo Etchebehere attended. This meeting aimed to review SDG 2 progress and identify areas for improvement with public-private collaboration.

On 9 April 2024, Undersecretary Lamas met with advisor of Energy, Environment, Science, Technology and Health of the United States Embassy, Sean Greenley.⁵⁴ This meeting included preparation for the presentation of the Biennial Transparency Report regarding compliance to commitments entailed in the Paris Agreement. In addition, the dialogue included plans to increase financing for green transition development.

On 11 April 2024, the Secretary of Environment, Tourism and Sports, Daniel Scioli, and Undersecretary Lamas met with representatives of the World Bank.⁵⁵ The dialogue entailed strategies of accessing private financing for sustainability projects in rural and nature tourism alongside forestry and agriculture. In addition, proposals for financing of sustainable tourism infrastructure were presented, reaffirming Argentina's commitment to Sustainable Development Goals.

On 18 April 2024, Undersecretary Lamas met with a representative of the Development Bank of Latin America and the Caribbean.⁵⁶ This meeting aimed to provide current updates on the financing of development projects underway and establish funding for future collaborative sustainable development.

On 19 April 2024, Undersecretary of Foreign Policy, Ambassador Marcia Levaggi met with climate change negotiating teams from Brazil, Paraguay and Uruguay to initiate the first coordination meeting of the Scientific Understanding of Risk Group.⁵⁷ This meeting consolidated multilateral commitments to sustainable development and discussion of negotiating issues including financing, technology and capacity building.

On 23 April 2024, Argentina participated in the third Conference of the Parties of the Escazú Agreement at the Economic Commission for Latin America and the Caribbean.⁵⁸ This multilateral meeting engaged the Escazú Agreement which promotes the distribution of environmental information to strengthen environmental protection. This dialogue reaffirmed Argentina's commitment to supporting Sustainable Development Goals.

On 23 April 2024, Undersecretary Lamas met with a representative of Germany's Gesellschaft für Internationale Zusammenarbeit, Corinna Kuesel.⁵⁹ This public-private partnership entailed the collaboration of sustainable development projects including the incorporation of renewable energy and forest management.

On 14 May 2024, the Undersecretariat of Aquatic Resources of the Bioeconomy, Secretariat of the Ministry of Economy of the Nation and the Food and Agriculture Organization launched a training activity regarding the control of fisheries.⁶⁰ This activity included the application of software and inspection and aimed to simultaneously target Argentina's goals with digital transition, digital infrastructure and sustainable development.

On 18 May 2024, Minister Mondino met with United States Secretary of State, Antony Blinken.⁶¹ This bilateral meeting included a signing of a Memorandum of Understanding, which entailed recommitment to cooperation on environmental sustainability.

On 20 May 2024, Minister Mondino met with representatives of Google Limited Liability Company including Global Vice President of Government Affairs and Public Policy, Karan Bhatia; the Vice

President of Government Affairs and Public Policies of Emerging Markets for Latin America, Africa, the Middle East and Russia, Doron Avni; and the Head of Government Affairs and Public Policy for Latin America, Eleonora Rabinovich.⁶² The public-private partnership meeting entailed dialogues addressing the development of Artificial Intelligence and collaboration on future digital transition strategies.

On 7 June 2024, Minister of Foreign Affairs, International Trade and Worship, Gabriel Martínez attended the fourth meeting of the Trade and Investment Council with Assistant United States Trade Representative for the Western Hemisphere, Daniel Watson.⁶³ This bilateral meeting aimed to strengthen trade relations and reconcile goals regarding digitalization of economies, focusing on artificial intelligence and environmental sustainability.

On 11 June 2024, Undersecretary Lamas met with Norway's Ambassador in Argentina, Kalvor Sætre, and the President of the Argentine Norwegian Chamber of Commerce, Sven Engevik in a bilateral meeting titled "Decarbonization and energy transition: What can we learn from the Norwegian economy?"⁶⁴ The meeting included bilateral dialogue on technological development to aid decarbonization strategies.

On 19 June 2024, Undersecretary Lamas met with Director of the Investment and Foreign Trade Bank, Nicolás Scioli.⁶⁵ The meeting entailed dialogues regarding financing with focus on environmental commitments. In addition, Lamas and Scioli discussed the promotion of financial inclusion and productive investment projects.

On 11 July 2024, Undersecretary Lamas met with Brazil's Minister Counsellor of the Embassy, Mauricio Fernando Dias Favero.⁶⁶ This meeting entailed bilateral dialogue on strengthening efforts regarding environmental sustainability in ongoing development projects. These projects target Mercosur, the Trinational Project in the South Atlantic and offshore exploration. Furthermore, strategies for progress in renewable energy were discussed and ongoing commitment to environmental protection was restated.

On 18 July 2024, Undersecretary of International Financial Relations Matiás Mana and Secretary of Finance Pablo Quirno participated in the Development Bank of Latin America and the Caribbean's approval of USD100 million for the increase of resource mobilization by ameliorating climate resilience of basic services and strengthening road-based infrastructure.⁶⁷

On 19 July 2024, Undersecretary Lamas met with government representatives to discuss issues related to fishing in Argentina.⁶⁸ Gabriela Navarro, Director of Fisheries Planning of the Undersecretariat of Fisheries and Aquaculture, noted the importance of reducing fishing gear to reduce environmental impact when they are so often lost.

On 24 July 2024, Undersecretary Lamas and the Director of Interjurisdictional and Access to Information, Viviana Zara, carried the award ceremony to the National Entity of Water and Sanitation Works (ENOHSA) and the National Parks Administration (APN), for meeting the objectives of the Public Body Committed to Sustainability, within the framework of the Sustainable Public Buildings program.⁶⁹ This ceremony not only celebrated achievements, but it reaffirms Argentina's commitment to a greener and more sustainable future.

On 1 August 2024, Undersecretary Lamas participated in the opening of a workshop which outlined an initiative created to strengthen the sustainable management of chemical substances and hazardous waste in Argentina during the period 2025-2030.⁷⁰ The meeting took place over three days and in attendance were representatives from a variety of areas of national and local government, representatives of the United Nations Development Programme, actors from the industrial sector and officials.

On 3 August 2024, Secretary Scioli and Undersecretary Lamas met with the French ambassador to Argentina, Romain Nadal, to discuss environmental issues shared by both countries, with special focus on energy transition, renewable energy, and green hydrogen.⁷¹ Willingness of French companies to collaborate on projects was made clear. Officials discussed ocean preservation, the Pampa Azul project, coastal planning, fishing, offshore exploration, and Maine Protected Areas.

On 9 August 2024, Undersecretary Lamas led a meeting with representatives of the Argentine Foreign Ministry, the Federal Fisheries Council, and the Argentine Naval Prefecture to discuss strategic components of the tripartite project Argentina, Brazil, Uruguay Large Aquatic Ecosystems of the Western South Atlantic situated within the international waters' axis of the Global Environment Facility.⁷² The meeting emphasized the importance of involving private sectors in the project and highlighted the willingness of teams from Brazil and Uruguay to advance joint work.

On 14 August 2024, Undersecretary Lamas and the Canadian ambassador, Reid Sirrs, met to discuss the current situation of fires that are occurring in both countries.⁷³ Different ways of addressing

environmental issues such as waste management, biodiversity, and marine ecosystems for sustainable management in Argentina and Canada were shared. Both countries agreed to collaborate on sustainable environmental development.

Argentina has fully complied with the commitment to progress SDGs. Argentina has achieved the commitment requirements, with strong development of inter-G20 partnerships to sustain commitments.

On 7 October 2024, Minister Mondino met with the Indian Minister of External Affairs, Subrahmanyam Jaishankar to discuss ways to expand bilateral trade and investment between the two countries in the energy sector, as well as in healthcare, agriculture, defense and technology. ⁷⁴These partnerships would support business opportunities and lead to joint development.

Australia: +1

Australia has fully complied with the commitment to take collective action for implementing the G20 2023 Action Plan to Accelerate Progress on the Sustainable Development Goals (SDGs), including its High-Level Principles.

On 14 December 2023, as part of the Government's additional \$48 million package aimed at supporting Australia's tourism and travel industry, \$10 million in funding was allocated to develop a national one-stop digital hub.⁷⁵ This grant was provided to Accommodation Australia to expand and promote its existing online platform, 'The Hub,' designed for tourism, travel, and hospitality employers and workers.

On 29 January 2024, the Government announced a \$35 million investment to continue the successful policing partnership between the Australian Federal Police and the Polícia Nacional de Timor-Leste (PNTL).⁷⁶ This commitment underscores Australia's dedication to supporting regional security and building capacity within the PNTL. Australia has fully complied with the commitment to international cooperation in law enforcement and security.

On 24 February 2024, ahead of the 13th World Trade Organization Ministerial Conference, the Australian Government announced an allocation of more than \$20 million to aid the region's trade and development needs.⁷⁷ This financial commitment to working with Indo-Pacific partners aims to build resilience and foster economic growth through trade, contributing to enhanced regional stability and prosperity. Australia has fully complied with the commitment to support trade and development in the Indo-Pacific region.

On 27 February 2024, Australia, issued a joint statement endorsing principles for the research and development of G6 wireless communication systems.⁷⁸ These principles aim for open, free, global, interoperable, reliable, resilient, and secure connectivity. By endorsing these principles alongside other countries, Australia demonstrates its full commitment to advancing 6G technology in alignment with global standards and collaborative efforts. Australia has fully complied with the commitment to the shared principles for 6G development.

On 15 March 2024, Tourism Minister Don Farrell and the Australian Tourism Industry Council (ATIC) launched the Tourism Emissions Reduction Program in Darwin.⁷⁹ This initiative is aimed at empowering tourism businesses to enhance their environmental sustainability, thereby boosting the competitiveness and marketability of Australia's attractions. Australia has fully complied with the commitment to promote sustainable tourism.

On 29 April 2024, the Australian Government introduced a \$1.4 million program to strengthen the tourism workforce in regional New South Wales, targeting young people, First Nations Australians, seniors, and people with disabilities.⁸⁰ This initiative supports Australia's commitment under the G20 2030 Action Plan to promote inclusive economic growth and sustainable employment, fully complied with the SDGs by 2030.

On 3 May 2024, Australia committed AUD492 million to the Asian Development Fund for the 2025-2028 pledging round. This funding, managed by the Asian Development Bank, aims to support transformative development projects across the Indo-Pacific region.⁸¹ It focuses on providing grants to lower-income developing countries to help reduce poverty and enhance the quality of life. This commitment reinforces Australia's role in regional development and cooperation, fully complying with its commitment to international cooperation in achieving the SDGs.

Australia has fully committed to the development and implementation of the SDGs through the G20 2030 Action Plan. Australia has fully complied with the commitment to bolster the tourism industry by building a strong, secure, and skilled workforce.

Thus, Australia receives a score of +1.

On 26 January 2024, Brazil reaffirmed its commitment to developing tourism in a sustainable way at the 27th Ibero-American Conference of Tourism Ministers and Entrepreneurs (CIMET).⁸² CIMET allowed for representatives from Brazil, Mexico, Colombia, Uruguay, Paraguay, Cuba, Nicaragua and Guatemala to present incentives and development plans in tourism, as well as investment from Spanish businesses in Latin America. Notably, Brazil emphasised the importance of encouraging sustainable tourism in an economically, environmentally, and culturally aware manner.

On 26 January 2024, Brazil's National Council for Industrial Development launched new industrial policy with development goals centered around innovation and sustainability.⁸³ This policy is expected to directly improve Brazilian quality of life, stimulating productive and technological development. BRL 300 billion in financing was allocated to the new industrial policy until 2026; another BRL 194 billion were incorporated from different sources as well to support this initiative.

On 5 February 2024 to 9 February 2024, Brazil hosted the Body of European Regulators for Electronic Communications (BEREC) to share knowledge regarding their domestic digital transformation.⁸⁴ During meetings, stakeholders such as the National Telecommunications Agency, Brazilian Ministry of Communications, Ministry of Science, Technology, and Innovation of Brazilian Chamber of Deputies, and BEREC Chairs and Vice-Chairs discussed the regulation of artificial intelligence, digital markets and cybersecurity. Representatives from Brazil and Europe presented recent regulatory developments and exchanged strategies for the digital revolution, prioritizing inclusion and connectivity.

On 21 February 2024 and 22 February 2024, the Brazilian Presidency recognized the United Nations Education, Scientific and Cultural Organization (UNESCO) as a privileged partner for the first time, enabling the organization to contribute to the work of G20.⁸⁵ Following an initial meeting with President Luiz Inacio Lula da Silva, UNESCO's Director-General Audrey Azoulay took part in the meeting of foreign ministers in Rio de Janeiro. Discussions centred on responses to international tensions and reforming global governance. This initiative showcases Brazil's leadership in coordinating collaborative efforts, exemplifying commitment to enhancing partnerships.

On 20 March 2024, Brazil put forth an anti-poverty and anti-hunger agenda to the G20 delegation.⁸⁶ The Brazilian administration proposed launching a Global Alliance Against Hunger and Poverty in November 2024, during the G20 summit in Rio de Janeiro, which demonstrates their dedication to prioritizing this issue through the G20 forum.

On 9 April 2024, the Brazilian National Telecommunications Agency (Anatel), UNESCO, and the Brazilian Ministry of the Environment (MRE) signed a technical agreement during the "Inteligência Artificial e o Futuro da Conectividade: uma Visão Coletiva" event.⁸⁷ This ultimately serves to bridge

the digital divide by providing digital literacy sources and internet access, and harnessing AI potential in agriculture, health, and education sectors.

On 9 October 2024, President Lula enacted the Fuel of the Future law which empowers programs to foster research, production, trade, and use of biofuels with the goal of promoting the decarbonization of the transportation and mobility matrices.⁸⁸ This marks an important step for the future of renewable energy in the country.

On 17 October 2024, the Ministry of Foreign Affairs' secretary for Climate, Energy, and Environment, Ambassador André Corrêa do Lago, and the Ministry of the Environment and Climate Change's national secretary for Climate Change, Ana Toni, presented the themes that Brazil will aim to support at COP 29.⁸⁹ Brazil will focus on the National Adaptation Plan as well as the Carbon Market system, both aiming to reduce greenhouse gas emissions.

Brazil has fully complied with its commitment to take collective action for effective and timely implementation of the G20 2023 Action Plan to Accelerate Progress on the SDGs. Brazil has consistently mobilized affordable and accessible financing to support developing countries, highlighted tourism and culture for sustainable socio-economic development and economic prosperity, recognized its role in digital transformation, and played a leading role in fostering international cooperation.

Thus, Brazil receives a score of +1.

Canada: +1

Canada has fully complied with the commitment to take collective action for implementing the G20 2023 Action Plan to Accelerate Progress on the Sustainable Development Goals (SDGs), including its High-Level Principles.

On 27 February 2024, Canada, issued a joint statement endorsing principles for the research and development of G6 wireless communication systems.⁹⁰ These principles aim for open, free, global, interoperable, reliable, resilient, and secure connectivity. By endorsing these principles alongside other countries, Canada demonstrates its full commitment to advancing 6G technology in alignment with global standards and collaborative efforts. Canada has fully complied with the commitment to the shared principles for 6G development.

On 12 March 2024, Minister of Environment and Climate Change, Steven Guilbeault, announced a new designated funding stream up to CAD 7.39 million under the Low Carbon Economy Fund's Indigenous Leadership Fund. Eligible applicants who are not already included in the funding streams

for First Nations, Inuit, and Métis can apply for benefits.⁹¹ This would benefit Indigenous-owned businesses; corporations and not-for-profit organizations; Métis Settlements; and Indigenous research, academic, or educational institutions.

On 16 April 2024, the executive director at Clean Energy Canada, Mark Zacharias, announced the CAD800 million budget allocated to the new Canada Greener Homes Affordability Program.⁹² The program aims to support the installation of energy efficiency retrofits for low-to-median income households. Additionally, CAD73.5 million will be provided to renew and modernize existing energy efficiency programs and to revitalize the development of stricter building codes to further reduce emissions and lower energy consumption, thereby improving the affordability of utility bills along with reducing carbon emissions.

On 19 April 2024, Prime Minister Justin Trudeau highlighted that over CAD4.6 billion will be spent on a package of measures to strengthen Canada's research and innovation. ⁹³ Investing in research and innovation will create more quality jobs, especially in innovation and technology, thereby enhancing Canada's production possibility frontier. Of this investment, CAD2.6 billion will be directed towards research grant funding, scholarships, and fellowships to support researchers. Additionally, CAD1.3 billion will be invested to keep post-secondary education affordable, and CAD734 million is planned to support research infrastructures and institutes. This investment in innovation and research is expected to increase human capital and drive sustainable economic development.

On 9 May 2024, Minister of Agriculture, Food and Rural Affairs Lisa Thompson announced the installation of a new broadband infrastructure in Wellington County as part of the commitment to expanding high-speed internet access to communities across the province.⁹⁴ The Ontario government is investing nearly CAD4 million to connect rural communities across the province to high-speed internet by the end of 2025 under the High-Speed Access for All: Canada's Connectivity Strategy, the largest single investment in high-speed internet in Canadian history.⁹⁵ Wellington County is one specific example of this initiative. The Canada's Connectivity Strategy will strengthen rural communities by ensuring that people can work and live where they choose from, thus this strategy facilitates an inclusive path to economic growth.

On 31 May 2024, Minister of Transport Pablo Rodriguez, announced up to CAD51.2 million for 19 digital infrastructure projects under the National Trade Corridors Fund (NTCF).⁹⁶ The NTCF is a Canadian government program that aims to support economic growth and development by facilitating

trade and transportation corridors across Canada through investing in critical infrastructure projects such as airports, ports, railways, access roads, and transportation facilities, thus enhancing efficiency, connectivity, and the movement of goods and people.

On 12 September 2024, Ahmed Hussen, Minister of International Development, and Andy Harrington, Executive Director of Canadian Foodgrains Bank, announced that Canada is providing CAD100 million over 4 years to the organization for emergency food and nutrition assistance.⁹⁷ The aim is to reduce global food insecurity and help those in need get access to essential food and nutrition services. This funding will provide critical assistance to the world's most vulnerable populations.

Canada has fully complied with its commitment to take collective action for effective and timely implementation of the G20 2023 Action Plan to Accelerate Progress on the SDGs.

Thus, Canada receives a score of +1.

China: 0

China has partially complied with the commitment to take collective action for implementing the G20 2023 Action Plan to Accelerate Progress on the Sustainable Development Goals (SDGs), including its High-Level Principles.

On 4 December 2023, China scrapped the entry visa requirement for travelers from Spain, the Netherlands, France, Germany, Italy and Malaysia so visitors are now able to travel visa-free to China for up to 15 days.⁹⁸ This trial period regarding visas is an attempt to boost inbound tourism for China and prompt "people-to-people exchanges." It marks an important move for China in "the high-level opening up" to the world.

On 29 January 2024 to 31 January 2024, China hosted the World Digital Education Conference in Shanghai to focus on the application, sharing, and innovation of digital technology.⁹⁹ During this event, ministers and chairmen hosted discussions regarding the importance of digitization in education. Domestically, they highlighted uses of big data and artificial intelligence, accessibility and inclusion in quality education resources, and approaches to strengthening good practices and ethics in digital realms. Internationally, they emphasized China's commitment to developing the International Institute for STEM Education of the United Nations Education, Scientific and Cultural Organization, and the state's significant contributions to enhancing global digital education.

On 22 February 2024, China launched a new program to increase national digital literacy intended to yield results by the end of 2024. The initiative is a joint effort by major governmental bodies in China, and sets a broad framework that aims to create a more comprehensive digital literacy and skill development system.¹⁰⁰ The plan outlines six key areas with 17 major tasks, including cultivating highlevel digital talent, fostering digital competence in schools, and ensuring all citizens have equal access to resources to reduce the digital divide.

On 7 March 2024, China's General Office of the State Council released new guidelines to optimize payment services across the country.¹⁰¹ By facilitating the use of cash and currency exchanges while incentivizing institutions to consider diversified payment options, China aims to provide higher-quality and more effective services for senior citizens and foreign visitors.

On 14 March 2024, China expanded its visa-free travel policy to include six additional European countries: Switzerland, Ireland, Hungary, Austria, Belgium, and Luxembourg.¹⁰² This will allow ordinary passport holders to travel in China for up to 15 days.

On 26 April 2024, the International Horticultural Exhibition 2024 Chengdu began with particular consideration to sustainable principles through management, ecological conservation, industry, city, and culture.¹⁰³ Some notable points include realising the goal of "integrated industry-city and city-park development," and promoting distinctive cultural aspects like Sichuan Bamboo Weaving and Sichuan Chinese Penjing.

China has partially complied with its commitment to take collective action for effective and timely implementation of the G20 2023 Action Plan to Accelerate Progress on the SDGs. They have consistently mobilized affordable and accessible financing to support developing countries, and highlighted tourism and culture for sustainable socio-economic development and economic prosperity. Notably, China performs very well in their recognition and progress in the role of digital transformation; however, they fall short on enhancing G20 cooperation and partnership.

Thus, China receives a score of 0.

France: 0

France has partially complied with the commitment to take collective action for implementing the G20 2023 Action Plan to Accelerate Progress on the Sustainable Development Goals (SDGs), including its High-Level Principles.

On 18 January 2024, France and Norway signed a partnership to enhance existing cooperation on green industrial transformation between the two countries. This partnership seeks to address shared challenges in sustainable development by leveraging the strengths of both countries. The partnership is structured around three prongs: structured dialogue on carbon capture and storage, structured dialogue on renewable energy, and structural dialogue on critical raw materials. This agreement also emphasizes the importance of cooperation between states and both countries' intention to regularly exchange views on current issues and developments in national and European policies.¹⁰⁴

On 23 January 2024, France chaired the 14th Summit of the Global Forum of Migration and Development. As chair, France facilitated discussion of the effects of climate change on human mobility and highlighted the cultural heritage acquired through migration. The protection of rights of migrants, diasporas, labour migration, links between migration and culture and discourse surrounding

migration, and multi-level governance of migration was examined using a cross-cutting approach and other thematic priorities of the French program.¹⁰⁵

On 6 February 2024, the French government established digital transformation through the creation of cyber security education and training. Recognizing the ever-growing importance of cybersecurity in today's world, this initiative seeks to prepare France for emerging digital challenges. Through job postings and a range of educational programs, France committed to developing a skilled workforce aimed to bridge the cyber security skills gap to address digital divides.¹⁰⁶

France has partially complied with the agreement towards collective action and implementation of the G20 2023 Action Plan to Accelerate the progress of the SDGs. Of the four components of the plan outlined, France has recognized the role of digital transformation and the need to address digital divides, highlighting the crucial role of tourism for sustainable socio-economic development, and enhancing G20 cooperation and partnerships to implement the 2030 Agenda. France does not fully comply as they lack affordable financing for developing countries.

Thus, France receives a score of 0.

Germany: +1

Germany has fully complied with the commitment to take collective action for implementing the G20 2023 Action Plan to Accelerate Progress on the Sustainable Development Goals (SDGs), including its High-Level Principles.

On 17 of February 2024, all online platforms that operate in Germany must publish their justifications for content moderation.¹⁰⁷

On 1 March 2024, the Federal Cabinet adopted an amendment to the Asylum Seekers' Benefits Act, which would allow asylum seekers to receive certain benefits in the form of a payment card.¹⁰⁸ This would make it easier for the government to get money to one of the most disadvantaged groups in Germany.

On 20 March 2024, the Federal Cabinet has adopted the National Reform Programme 2024. According to the programme, the German government is increasing job availability and helping citizens with gaining qualifications.¹⁰⁹ The government is also investing in climate friendly infrastructure and power while funding the digitalization of the economy, infrastructure, and education. The purpose of this programme is to facilitate cooperation within the European Union, including other G20 members.

On 16 April 2024, Chancellor Olaf Scholz visited China to discuss "Joint sustainable action."110

On 22 April 2024, Chancellor Scholz opened a trade fair in Germany.¹¹¹ The purpose of the fair was to examine digitalization and slow climate change.

On 26 April 2024, Germany co-hosted the Petersberg Climate Dialogue, where Chancellor Scholz urged G20 members to adhere to their Paris Climate Agreement targets.¹¹² He also pledged financial support to poor countries and those suffering from climate change. He emphasized the importance of investing in sustainable production and technology.

On 15 June 2024, Germany, as part of the G7, agreed to increase support for sustainable development in African countries. ¹¹³ Germany also pledged to move away from fossil fuels faster.

On 17 July 2024, Germany announced its 2025 budget, with a focus on investments in affordable housing, digital infrastructure and education, and climate action.¹¹⁴

On 8 October 2024, Germany hosted the sixth Climate and Security Conference at the Federal Foreign Office in Berlin.¹¹⁵ The conference brought together high-level politicians, climate security experts, and international organizations. The focus was on the link between the climate crisis and security goals with emphasis on the contributions that the security industry can provide to help induce peace and stabilize volatile regions.

Germany has fully complied with its commitment towards collective action and the implementation of the G20 2023 Action Plan to Accelerate progress on the Sustainable Development Goals. Germany has clearly committed itself to the fulfilment of its Sustainable Development Goals, only occasionally lacking follow-through. Germany has taken strong, tangible action in economic and environmental spheres and has encouraged other G20 countries to do the same. Germany's momentum is somewhat stalled in the social sphere, but it is nonetheless working to financially support its citizens.

Thus, Germany receives a score of +1.

India: +1

India has fully complied with the commitment to take collective action for implementing the G20 2023 Action Plan to Accelerate Progress on the Sustainable Development Goals (SDGs), including its High-Level Principles.

On 13 December 2023, India hosted the Global Partnership on AI [artificial intelligence] Summit, resulting in the adoption of the New Delhi resolution by 29 members.¹¹⁶ The declaration acknowledges the need to harness new opportunities and mitigate the risks arising from the development and deployment of AI. It promotes the collaborative effort of member states on AI, focusing on the inclusivity of countries from the Global South.

On 11 January 2024, the Tourism Minister of Goa, Rohan Khaunte announced Goa's new model of Regenerative Tourism.¹¹⁷ The new model will promote environmental restoration, cultural preservation and community empowerment to guide its approaches to sustainable travel and tourism.

On 19 January 2024, the Government of India endorsed the Global Good Alliance for Gender Equity and Equality, launched at the World Economic Forum (WEF) meeting in Davos, Switzerland.¹¹⁸ The alliance is supported by the Bill and Melinda Gates Foundation and will be housed by the CII Centre for Women Leadership. It is supported by over 10,000 partners from industries worldwide, with the WEF as a 'network partner' and Invest India as an 'institutional partner'. It aims to bring together practices, knowledge and investment in areas of women's health, education and enterprise, building on India's commitment to women-led development.

On 13 February 2024, the Government of India signed an Inter-Governmental Framework Agreement on the India-Middle East-Europe Corridor with the United Arab Emirates. The agreement aims to promote bilateral cooperation between the two countries in the ports, maritime and logistics sectors.¹¹⁹ It is part of the Partnership for Global Infrastructure Investment, founded by the G7 in 2023 to narrow the infrastructure gap in developing countries and accelerate progress on the SDGs.¹²⁰

On 20 February, the Government of India signed loan agreements with the Japan International Cooperation Agency to receive official development assistance (ODA) loans of up to JPY232,209 million for 9 developmental projects. These include the Project for Promoting Start-up and Innovation in Telangana, Project for the Construction of Chennai Peripheral Ring Road, and others. The agreement enhances bilateral relations and mutual development, supporting India's fulfilment of the SDGs.¹²¹

On 21 February, Minister of State for External Affairs and Parliamentary Affairs Shri V. Muraleedharan attended the G20 Foreign Ministers' Meeting in Rio de Janeiro, Brazil.¹²² The goal was to enhance

cooperation between G20 members and address issues of global concern. On the sidelines, he also held bilateral meetings with partner countries of the Global South.

On 22 February, Minister Muraleedharan attended the India-Brazil-South Africa (IBSA) Standalone Meeting in Rio de Janeiro.¹²³ IBSA was created to enhance trilateral cooperation in sectoral areas, providing a framework for South-South Cooperation. Ministers agreed to leverage international cooperation to ensure food security and nutrition and promote the IBSA Fund, among other issues. They highlighted the need to strengthen means for full implementation of the SDGs, including capacity building, transfer of technology, grants and concessional finance from developed countries and revitalizing the Global Partnership for Sustainable Development. They urged developed countries to fully honor their ODA commitments.

On 27 February 2024, the Department of Tourism, Government of Goa, and MakeMyTrip signed a Memorandum of Understanding (MoU), signifying their public-private partnership.¹²⁴ The MoU outlines a series of innovative initiatives for Goa tourism, ensuring sustainable and regenerative tourism practices.

On 4 March 2024, NITI Aayog, the apex public policy think tank of the Government of India, organised the 'National Conference on Accelerating Sustainable Development Goals' together with the Government of Rajasthan as its host and technical partners UN Development Programme and the UN in Jaipur, India.¹²⁵ The conference aimed to encourage states to take stock of SDGs localisation, exchange experiences on institutionalising the SDGs at the subnational level, explore national and subnational level finance and accelerate progress towards the 2030 Agenda.

On 7 March 2024, Minister of External Affairs Subrahmanyam Jaishankar held the 16th Japan-India Foreign Minister's Strategic Dialogue with Japanese Minister for Foreign Affairs Yoko Kamikawa.¹²⁶ They discussed topics of bilateral relations, including promoting cooperation in the area of defense equipment and technology, as well as an extension of the "Japan-India Tourism Exchange Year" to be implemented in 2024.

On 24 April 2024, Prime Minister Narendra Modi addressed the 6th edition of the International Conference on Disaster Resilient Infrastructure hosted in New Delhi. Prime Minister Modi reiterated the global success of the Coalition for Disaster Resilient Infrastructure, founded by India in 2019 and now composed of 39 countries and seven organisations. The initiative strengthens global climate resilience by mobilizing accessible financing for developing countries.¹²⁷

On 18 May 2024, Foreign Secretary Vinay Kwatra and Sir Philip Barton, Permanent Under-Secretary at the Foreign Commonwealth and Development reaffirmed their commitment to conclude a mutually

beneficial free trade agreement at the annual UK-India Strategic Dialogue in London. ¹²⁸ This agreement will strengthen their bilateral relationship and make progress towards the 2030 Roadmap.

On 8 July 2024, Prime Minister Modi attended the 22nd India-Russia Annual Summit in Russia, at the invitation of President Vladimir Putin.¹²⁹ The leaders affirmed the continued strengthening of their bilateral partnership, including cooperation in trade, investments, security, energy, and technology. This enhances bilateral relations and mutual development in the G20.

On 12 July 2024, NITI Aayog released SDG India Index 2023-24, the country's primary tool to measure and track national progress on the SDGs. ¹³⁰ The index resulted in a composite score of 71, up from 66 in 2020-21 and 57 in 2018. This indicates India's significant progress in goal areas such as poverty eradication, decent work, economic growth, climate action and life on land.

India has fully complied with its commitment to take collective action for effective and timely implementation of the G20 2023 Action Plan to Accelerate Progress on the SDGs. India took steps to enhance G20 cooperation by signing agreements with member states and establishing various partnerships with the private sector. India has addressed the role of digital transformation and sustainable tourism with the implementation of domestic policies.

Thus, India receives a score of +1.

Indonesia: +1

Indonesia has fully complied with the commitment to take collective action for implementing the G20 2023 Action Plan to Accelerate Progress on the Sustainable Development Goals (SDGs), including its High-Level Principles.

On 5 February 2024, Indonesia spearheaded the establishment of an alliance of countries at the United Nations in New York.¹³¹ This initiative is aimed at bolstering the global response to tuberculosis, ensuring that efforts to handle the disease are consistently applied across the globe.

On 29 February 2024, the Indonesian Chamber of Commerce and Industry signed a Memorandum of Understanding with Câmara de Comércio e Indústria Portuguesa (Portugal Chamber of Commerce and Industry).¹³² This agreement marks a significant step in enhancing the business and trade relations between the two countries, facilitating increased collaboration and investment opportunities.

On 7 March 2024, the Indonesian Government, through the Indonesian Agency for International Development (Indonesia Aid)/Lembaga Dana Kerja Sama Pembangunan Internasional (LDKPI),

dispatched aid consisting of 10 million doses of Bivalent oral polio vaccine to Afghanistan.¹³³ This action demonstrates Indonesia's active role in supporting global health initiatives and addressing urgent health crises.

On 8 March 2024, Universitas Negeri Malang from Indonesia and Fiji National University formalized their commitment for strengthening academic collaboration in the fields of research, innovation, and technology development between Indonesia and Fiji by signing a Memorandum of Understanding.¹³⁴ This agreement serves as a concrete step towards strengthening the research and academic collaboration between the two countries, aiming to foster knowledge exchange, joint research projects, and academic mobility.

On 15 March 2024, Indonesia announced a new initiative to foster cooperation and capacity building for a sustainable bamboo industry with Fiji.¹³⁵ This collaboration aims to enhance sustainable economic growth, environmental conservation, and strengthen bilateral ties between the two countries.

On 3 May 2024, Indonesia and Vietnam agreed to target a bilateral trade volume of USD 18 billion by 2028, an increase from the previous goal of USD 15 billion.¹³⁶ This decision was made during discussions in Hanoi, Vietnam, emphasizing the need for both countries to reduce trade barriers and swiftly conclude agreements on food security. Additionally, they aim to optimize the function of the Joint Committee on Economic, Scientific and Technical Cooperation to enhance collaboration. This move reflects a strong commitment to deepen economic ties and foster regional cooperation.

On 8 October 2024, the Indonesian government announced plans to provide humanitarian assistance to Yemen, Sudan, Palestine and Vietnam, in light of the natural disasters and armed conflicts they are facing. ¹³⁷The aid will total USD 1 million. This is part of an ongoing effort from Indonesia to assist its neighbours in times of crises.

On 9 October 2024, Secretary of the National Disaster Mitigation Agency, Rustian and Australian Deputy Ambassador to Indonesia, Gita Kamath signed an agreement to extend their disaster risk management preparedness and humanitarian cooperation until 2027. ¹³⁸The cooperation is expected to be broader and more effective going forward. This partnership will enhance Indonesia's

preparedness form disasters, while also strengthening humanitarian cooperation in the Indo-Pacific region.

Indonesia has fully complied with its commitment to take collective action for effective and timely implementation of the G20 2023 Action Plan to Accelerate Progress on the SDGs. They have consistently initiated and supported global partnerships, highlighted the importance of shared responsibility in achieving the SDGs, recognized its role in fostering international cooperation, and played a leading role in addressing global challenges through actionable commitments.

Thus, Indonesia receives a score of +1.

Italy: +1

Italy has fully complied with the commitment to take collective action for implementing the G20 2023 Action Plan to Accelerate Progress on the Sustainable Development Goals (SDGs), including its High-Level Principles.

On 2 December 2023, Minister of the Environment and Energy Security Gilberto Pichetto and Ethiopia's Minister for Planning and Development Fitsum Assefa signed a bilateral Memorandum of Understanding at the Conference of the Parties 28.¹³⁹ This bilateral agreement outlines a renewed commitment to energy security priorities. In addition, the act approved six projects and relaunched four projects regarding carbon emission reductions and adaptation, entailing financial investment of EUR7.2 million.

On 3 December 2023, the Ministry of Environment and Energy Security signed its membership of the Amazon Fund, investing EUR5 million at the Conference of the Parties 28.¹⁴⁰ The fund aims to support public and private bodies in the Amazon region to plan and implement sustainable development frameworks and support multilateral partnerships in environmental cooperation.

On 4 December 2023, the Minister of Environment and Energy Security, Vannia Gava, attended the multilateral Res4Africa and GSE event titled "Gearing up Africa's energy transition by conducive policy and legislative frameworks." during the Conference of the Parties 28.¹⁴¹ During this event, Minister Gava announced a contribution of EUR5 million to the Sustainable Energy Fund for Africa Special fund. This contribution aims to promote financial and development inclusion for African countries.

On 7 December 2023, Undersecretary for Foreign Affairs Maria Tripodi met with Deputy Secretary General of the Association of Southeast Asian Nations Michael Tene.¹⁴² The meeting aimed to reaffirm

multilateral commitments to Southeast Asian development through sustainable development initiatives. The discussion focused on increasing food security, energy transition and the prevention and management of natural disasters in Southeast Asia.

On 9 December 2023, Minister of the Environment and Energy Security Gilberto Pichetto Fratin and Peru's Minister of Energy and Mines Albina Ruiz Ríos signed a Memorandum of Understanding.¹⁴³ This agreement entails the expansion of bilateral cooperation regarding the Rio Conventions, Convention on Biological Diversity and sustainable development objectives outlined in the 2030 Agenda.

On 13 December 2023, the Ministry of Foreign Affairs and International Cooperation and Ministry of Economy and Finance announced DEVELOPMENT+.¹⁴⁴ This instrument is a part of the Rotating Fund for Development Cooperation aimed at encouraging investments in sustainable development of partner countries in the Italian Cooperation.

On 30 January 2024, the Ministry of Tourism participated in the European D3HUB project initiation meeting.¹⁴⁵ The D3HUB project aims to create a multilateral, European competence centre to support tourist destinations in transition to more sustainable tourism and management.

On 7 February 2024, the Presidency engaged in a multilateral, virtual meeting with the G7 Trade Ministers.¹⁴⁶ The goal of this meeting was to reaffirm G7 and World Trade Organization trade-related commitments, including sustainable development and inclusive growth.

On 12 February 2024, the Italian Agency for Development Coordination announced a EUR180 million Tender Notice.¹⁴⁷ This will be allocated to sustainable development programs in Africa and other countries. This initiative commits to Italy's contributions in achieving the United Nations sustainable development goals.

On 27 February 2024, Prime Minister Giorgia Meloni met with Croatia's Prime Minister Andrej Penković.¹⁴⁸ This bilateral engagement aimed to reaffirm commitments to sustainable development, by outlining a framework for collaboration to pursue long-term sustainability of fishing and sustainable consumption patterns.

On 2 March 2024, Prime Minister Meloni met with Canada's Prime Minister, Justin Trudeau. This bilateral meeting included discussions on delivering sustainable prosperity and a recommitment to

economic partnerships, including G7 commitments to promote sustainable economic growth.¹⁴⁹ Furthermore, it established the Canada-Italy Roadmap for Enhanced Cooperation, which will promote a bilateral shift in promoting sustainable development goals.

On 15 March 2024, Undersecretary of State for technological Innovation Alessio Butti chaired the G7 Ministerial Meeting on Industry, Technology and Digital.¹⁵⁰ This meeting concluded a multilateral declaration on the use of collaborative digital governance including artificial intelligence to promote sustainable growth through the Hiroshima Artificial Intelligence Process.

On 17 March 2024, Prime Minister Meloni met with Egypt's President Abdel Fattah El-Sisi.¹⁵¹ The bilateral dialogues included the implementation of the Mattei Plan for Africa, which entailed subsequent bilateral agreements, including a financial package of EUR100 million for sustainable development.

On 21 March 2024, Chair of the Italian National Tourist Board Alessandra Priante alongside Andorra's Prime Minister Xavier Zamora, Minister of Tourism, Jordi Torres and Spain's Secretary of State for Tourism Rosanna Murillo attended the World Congress on Mountain Tourism in Andorra.¹⁵² This multilateral meeting aimed to create strategies on sustainable tourism development such as diversification, technological innovation and nature conservation. This meeting including the establishment of a permanent working table.

On 8 April 2024, Minister of Business and Made in Italy Adolfo Urso met with France's Minister for Economy, Finance and Industrial and Digital Sovereignty Bruno Le Maire and Germany's Minister for Economic Affairs and Climate Action Robert Habeck.¹⁵³ This trilateral meeting engaged perspectives on sustainable development and reaffirmed commitments to promoting sustainable industrial growth.

On 15 April 2024, the Italian G7 Presidency alongside the United Nations Development Programme met with Director General of the African Union Commission Fathallah Sijilmassi.¹⁵⁴ These parties were joined by other representatives of the African Union. These dialogues entailed plans to strengthen collaboration on Artificial Intelligence for sustainable development and addressing technological divides.

On 16 April 2024, the Ministry of Economy and Finance engaged in the Multilateral Development Banks Callable Capital Exercise meeting.¹⁵⁵ This multilateral meeting aimed to provide innovative dialogue in regard to expanding the Multilateral Development Banks financing capacity. This reaffirms Italy's commitment to Sustainable Development Goals through the acquisition of equitable financing.

On 17 April 2024, Prime Minister Meloni met with Tunisian Republic Kais Saied. This meeting included the signing of three agreements to bolster the sustainable development of Tunisia.¹⁵⁶ The first agreement included awarded a financial package to Tunisia to support renewable energy industries and sustainable energy objectives. The second agreement supported a financial package for Tunisia's small and medium-sized enterprises. The final agreement included a collaborative framework for higher education matters.

On 17 April 2024, Ms Priante of the Italian National Tourist Board attended a European Union Dialogue.¹⁵⁷ This dialogue aimed to explore the European Union Tourism route with a focus on green transition and sustainability. She engaged with ideas to expand public-private partnerships to achieve transitionary outcomes.

On 19 April 2024, Foreign Minister Antonio Tajani attended the G7 meeting of Foreign Ministers on "Addressing global challenges, promoting partnerships."¹⁵⁸ The multilateral dialogue included a plan to mobilize USD600 billion by 2017 to invest into global infrastructure and investment. Furthermore, the ministers launched two initiatives, the Blue Dot Network and the Finance to Accelerate the Sustainable Transition Infrastructure to mobilize increased private financing.

On 22 April 2024, Minister Urso met with Minister of Communication and Information Technologies of the Arab Republic of Egypt Amr Talaat.¹⁵⁹ The bilateral meeting entailed dialogue regarding the oversight of the Mattei Plan for Africa. This included discussions on the digital economy development through construction of an Artificial Intelligence Hub for Sustainable Development in Egypt.

On 23 April 2024, Prime Minister Meloni met with United States of America's Secretary of Commerce Gina Raimondo.¹⁶⁰ This meeting included reaffirmed bilateral commitments to strengthen technological sectors such as the applications of artificial intelligence.

On 30 April 2024, the Ministry of the Environment and Energy Security signed the Joint Declaration of the G7 members.¹⁶¹ This supported the ratification of the Biodiversity Beyond National Jurisdiction agreement and entailed a financial package of USD34 billion from the Council of the Global Environment Fund to bolster sustainability projects.

On 10 May 2024, Minister Urso met Deputy Minister Valentino Valentini and the United Arab Emirates' Minister of Economy, Abdulla bin Touk Al Marri.¹⁶² This bilateral meeting aimed to outline investment goals regarding collaboration on renewable energy and development of artificial intelligence and consolidated the Mattei Plan.

On 22 May 2024, Deputy Minister Valentini met with France's Undersecretary of State of the Ministry of Economy, Finance, and Industrial and Digital Sovereignty, Marina Ferrari at the Paris VivaTech show during the Paris Expo Porte de Versailles.¹⁶³ This event included discussions regarding artificial intelligence development and technological innovation

On 27 May 2024, Minister Urso signed a joint declaration with Tunisia's Minister of Communication Technology, Nizar Ben Neji.¹⁶⁴ The bilateral agreement aimed to strengthen collaborative initiatives in artificial intelligence and digital transition research for sustainable development, under the Mattei Plan.

On 5 June 2024, Minister of Economy and Finance, Giancarlo Giorgetti virtually participated in the Stimulus Leaders Group for the Stimulus Plan for Sustainable Development.¹⁶⁵ This meeting reaffirmed Italy's commitment to sustainable development through dialogues on multilateral financing strategies and financial inclusion of at-risk countries.

On 13 June 2024, Prime Minister Meloni met with US President Joe Biden and representatives of the United States private financial, energy, technological sectors at the Apulia Summit.¹⁶⁶ This meeting aimed to strengthen financing coordination for sustainable development along the Lobito Corridor amongst other sustainable development projects in Kenya.

On 15 June 2024, Prime Minister Meloni met with President of the World Bank Group Ajay Banga during the Apulia Summit.¹⁶⁷ This bilateral meeting included dialogues regarding the progress of co-financing initiatives for Italy's development framework in the Mattei Plan for Africa.

On 15 June 2024, Prime Minister Meloni met with the President of Algeria, Abdelmadjid Tebboune.¹⁶⁸ This dialogue aimed to strengthen bilateral partnerships in sustainable development projects, including energy, agriculture and industrial sectors. The meeting focused on public and private partnerships including the participation of Italian agro-industrial group, Bonifiche Ferraresi SpA and Algerian partners in a bilateral sustainable agriculture project.

On 20 June 2024, Minister Tajani participated in the Protecting Our Future – The Global Forum for Vaccine Sovereignty and Innovation to launch the African Vaccine Manufacturing Accelerator initiative.¹⁶⁹ The event was organized by France, the African Union and the Global Vaccine Alliance. The initiative is a financing mechanism to promote expedited vaccine development in Africa. Minister Tajani announced Italy's financial contribution of USD150 million.

On 24 June 2024, Prime Minister Meloni met with Singapore's President, Tharman Shanmugaratnam.¹⁷⁰ The meeting aimed to strengthen bilateral commitments to investments and cooperation on advancing critical aspects of the SDGs including artificial intelligence and renewable energy.

On 28 June 2024, Minister Tajani chained the fourth meeting of the Joint Committee for Development Cooperation in which financing of EUR300 million was approved for global development projects.¹⁷¹ Additionally, the Committee established two new offices of the Agency of Development Cooperation in Kampala, Uganda and Abidjan, Ivory Coast. The financing project aimed to envelope two new countries, Kyrgyzstan and Tajikistan.

On 4 July 2024, Prime Minister Giorgia Meloni met with Finland's President Alexander Stubb.¹⁷² This bilateral meeting included dialogues regarding strategic commitments to global development, notably the progress of the Mattei Plan.

On 8 July 2024, the Government of Italy contributed EUR5 million in core resources to the United Nations Development Programme (UNDP).¹⁷³ This financing is critical to sustaining UNDP's functioning and international development plans in tangent with the SDGs.

On 8 July 2024, Director General for Development Cooperation of the Ministry of Foreign Affairs, Stefano Gatto, and Mozambique's Minister of Economy and Finance, Ernesto Tonela. signed an agreement for the Construction and Equipment of the Manica Agri-Food Centre.¹⁷⁴ This agreement ensured EUR38 million in financing to resources to strengthen food security, sustainable agriculture and female entrepreneurship. Included objectives are underlined by the SDGs.

On 9 July 2024, Minister Tajani facilitated the delivery of a newly developed scanner to Cyprus.¹⁷⁵ This scanner was developed to navigate emergency aid to Gaza as a part of the Italian government initiative titled "Food for Gaza." This promotes the SDGs through the promotion of food security and closing the digital divide.

On 9 July 2024, Minister of Universities and Research Anna Bernini hosted the ministerial meeting of the Group of Seven on science and technology in Bologna, Italy.¹⁷⁶ This multilateral meeting created a forum to discuss strategies of promoting global technological excellence and contributed towards progress of sustainable development and efforts of closing the digital divide.

On 3 October 2024. Prime Minister Meloni met with the President of the Kyrgyz Republic, Sadyr Japarov, at Palazzo Chigi. Several bilateral agreements were signed that aim to increase cooperation in the fields of justice and culture, and to strengthen collaboration in areas of common interest.¹⁷⁷ They also discussed the main issues on the regional and international arena. The visit confirms Italy's commitment to continue to collaborate with Central Asian states.

Italy has fully engaged in actions and collaboration to promote the SDGs. Objectives must require more clarity including metrics for effectiveness. Furthermore, Italy's foreign direct investment remains focused in a selective geographical region. Italy has actively participated in international partnerships and collaborations.

Thus, Italy receives a score of +1.

Japan: +1

Japan has fully complied with the commitment to take collective action for effective and timely implementation of the G20 2023 Action Plan to Accelerate Progress on the Sustainable Development Goals (SDGs) including its High-Level Principles..

On 19 December 2023, Prime Minister Fumio Kishida held the 14th meeting of the SDGs Promotion Headquarters at the Prime Minister's Office. The meeting consisted of discussions regarding the second revision to Japan's SDGs Implementation Guiding Principles.¹⁷⁸ In a speech, Kishida reiterated his focus on building a sustainable economic and social system under his "New Capitalism" policy, which compiles investments in human capital and promotes Japan's green and digital transformation.

On 3 February 2024, Minister for Digital Transformation Taro Kono hosted the Ministerial Session on the Future of Data Governance in Asia and Operationalization of "Data Free Flow with Trust (DFFT)" in Singapore. The meeting included discussions on the progress of DFFT and future collaborations on the sustainable and inclusive development of data governance in Asia. The session strengthened cooperation between Japan and the Asian countries, recognizing the necessity of global digital transformation.¹⁷⁹

On 20 February 2024, the Japan International Cooperation Agency signed loan agreements with the Government of India to provide Official Development Assistance loans of up to JPY232,209 million for nine developmental projects. These include the Project for Promoting Start-up and Innovation in Telangana, Project for the Construction of Chennai Peripheral Ring Road, and others. The agreement enhances bilateral relations and mutual development, demonstrating Japan's commitment to mobilizing accessible funding for developing countries.¹⁸⁰

On 21 February 2024, Minister for Foreign Affairs Yoko Kamikawa attended the G20 Foreign Ministers' Meeting in Rio de Janeiro, Brazil. The goal was to enhance cooperation between G20 countries and address issues of global concern. Ms. Kamikawa restated Japan's commitment to working with its partners in the international community, including the Brazilian G20 Presidency.¹⁸¹

On 7 March 2024, Minister for Foreign Affairs Yoko Kamikawa held the 16th Japan-India Foreign Minister's Strategic Dialogue with Indian Minister of External Affairs, Subrahmanyam Jaishankar. They discussed topics of bilateral relations, including promoting cooperation in the area of defense equipment and technology, as well as an extension of the "Japan-India Tourism Exchange Year" to be implemented in 2024.¹⁸²

On 10 March 2024, the Government of Japan donated USD5 million to the Pan-American Highway for Digital Health Initiative, led by the Inter-American Development Bank (IDB) and Pan American Health Organization. This initiative aims to enhance digital health services in Latin America and the Caribbean. The donation was made through the Japan Special Fund at the IDB, which has made

significant contributions since its establishment in 1988.¹⁸³ It demonstrates Japan's commitment to mobilizing accessible funding to developing countries.

On 20 March 2024, the Japan Youth Platform for Sustainability held the "Youth-led 'Action and Transformation' Summit for the Future." The event aimed to strengthen youth networks and promote youth participation in dialogue surrounding the SDGs, acting as a kick-off event to advance discussions towards Japan's Voluntary National Review for 2025. Deputy Director-General Hideki Kusakabe of the International Cooperation Bureau participated in the event alongside expert and youth panellists.¹⁸⁴ This event enhances domestic partnerships to implement the 2030 SDGs Agenda.

On 10 April 2024, Prime Minister Kishida made an official visit to Washington DC to meet with President Joe Biden. At the summit they reaffirmed their commitment to the US-Japan bilateral partnership, including defence cooperation and private sector-led two-way investment to lead global economic growth.¹⁸⁵

Japan has fully complied with its commitment to take collective action for effective and timely implementation of the G20 2023 Action Plan to Accelerate Progress on the SDGs. Japan took steps to mobilize accessible financing for developing countries and worked to strengthen G20 cooperation through engagement in bilateral dialogue. Japan recognized the importance of sustainable and digital transformations through public engagement and announcing the implementation of new domestic socio-economic policies.

Thus, Japan receives a score of +1.

Korea: +1

Korea has fully complied with the commitment to take collective action for implementing the G20 2023 Action Plan to Accelerate Progress on the Sustainable Development Goals (SDGs), including its High-Level Principles.

On 1 December 2023, the Ministry of Environment announced that Korea will participate in five global initiatives led by the United Arab Emirates covering renewable energy and energy efficiency, mutual recognition of hydrogen certification systems, agriculture and food, health, and multi-level cooperation.¹⁸⁶ This strong and multilateral action shows Korea's progress towards their environmental goals.

On 20 February 2024, the Korea International Cooperation Agency and the U.S. Agency for International Development signed a Memorandum of Understanding that aims to advance shared global development goals in India.¹⁸⁷ This strong action agreement seeks to leverage capacities to tackle

"women's economic empowerment, disaster and climate resilience, digital literacy, and opportunities for trilateral cooperation with the Government of India."

On 29 February 2024, Prime Minister Han Duck-Soo announced a budget allocation of KRW6.3 trillion for official development assistance (ODA), a fund organized by the Organisation for Economic Co-operation and Development (OECD) that is tasked with coordinating aid policy for developing countries.¹⁸⁸ This strong-action policy shows an increased ODA commitment that can aid progress towards economic and social objectives in developing countries.

On 14 March 2024, Cho Tae-yul, Minister of Foreign Affairs, gave a speech at the Global Engagement and Empowerment Forum on Sustainable Development where he highlighted the country's capacity to support SDG goals by acting as a bridge between Global North and South, advancing global public goods, and initiating new global norms and standards.¹⁸⁹ This less than strong action reaffirms Korea's commitment to tackling the SDGs.

On 20 March 2024, the government of Korea and the Economic Commission for Latin America and Caribbean renewed their cooperation agreement to enhance education, vocational training, digital inclusion, resilient investments in renewable energy, and productive integration of older persons.¹⁹⁰ The strong action aims to help the region pursue sustainable, and inclusive growth through tackling economic and social issues.

On 21 March 2024, representatives from Korea and the European Union held their 20th Joint Committee where they reiterated their commitment to multilateralism, and their cooperation with other G20 members.¹⁹¹ This less than strong action reaffirms cooperative actions to address the SDGs.

On 17 April 2024, the Finance Ministers of Japan, Korea, and the United States held a trilateral meeting that reaffirmed their commitment to work together to "evolve the multilateral development banks and strengthen other international financial institutions to better respond to key global challenges."¹⁹² This less than strong action demonstrates a cooperative commitment towards some economic-orientated High-level Principles.

On 25 April 2024, the Ministry of Economy and Finance of Korea and the OECD agreed to start a multi-year research program focused on securing fiscal sustainability, fiscally efficient elderly poverty alleviation policies and international comparison of tax expenditures and budget expenditures.¹⁹³ This strong action might generate potential policy solutions towards economic and social goals for multiple economies.

Korea has fully complied with its commitment to take strong action in each of all three overarching pillars of economic, social and environmental, in line with the High-Level Principles. Korea has initiated multiple collaborative policies with other countries and international organizations. These policies are both inclusive and collaborative.

Thus, Korea receives a score of +1.

Mexico: 0

Mexico has partially complied with the commitment to take collective action for implementing the G20 2023 Action Plan to Accelerate Progress on the Sustainable Development Goals (SDGs), including its High-Level Principles.

On 20 February 2024, the Secretariat of the Navy, the Ministry of the Government of Mexico, the United Nations Educational, Scientific and Cultural Organization, the Ministry of Tourism of the State of Nayarit, and Airbnb joined forces to promote sustainable tourism development in the Islas Marias Biosphere Reserve. Implemented projects, like Adaptur and Kuxatur, aim at adapting to climate change and conserving the region's biodiversity.¹⁹⁴ The alliance aims to focus on heritage management for sustainable tourism, strengthening of services that promote responsible tourism, and dissemination strategies to establish the Islas Marias as a premier destination in Mexico.

On 22 September 2024, Foreign Secretary Alicia Bárcena participated in the Summit of the Future at the 79th session of the United Nations General Assembly.¹⁹⁵ The summit was focused on the multilateral system with a focus on addressing international challenges. Bárcena reinforced Mexico's commitment to multilateralism as a tool to achieve equitable, inclusive and sustainable development.

Mexico has partially complied with its commitments towards collective action and the implementation of the 2030 G20 Action Plan. Out of the four parameters outlined, Mexico successfully complied with one of them. Mexico has highlighted the crucial role of tourism as a means for sustainable socioeconomic development and economic prosperity. However, Mexico falls short in other areas of the action plan. Mexico has failed to acknowledge the role of digital technology in bridging the digital divide, has not mobilized affordable financing to support developing countries, and could improve in its approach to strengthening G20 cooperation for the implementation of the 2030 Agenda.

Thus, Mexico receives a score of 0.

On 22 January 2024, Russia and Vietnam resumed flights to promote tourism between the countries.¹⁹⁶

On 27 January 2024, Russia and China cooperated on a "Made in Russia" festival in Shenyang to promote cultural exchange, opening the Cultural Cross Year of Russia and China.¹⁹⁷

On 6 February 2024, Russia implemented the Internet Access project, with the objective of improving telecommunications infrastructure, particularly in areas that are not well connected and schools.¹⁹⁸

On 15 February 2024, the Russian government drafted legislative amendments to offer more tax exemptions for the Era Technopolis, a centre for innovation.¹⁹⁹

On 15 February 2024, the Russian government announced the allocation of RUB 1 billion to develop ski complexes for tourists.²⁰⁰

On 21 February 2024, the Russian government amended the rules for financing projects to allow certain regions to obtain financing for the construction of infrastructure for companies at technology parks.²⁰¹

On 26 February 2024, Russia increased the number of openings for certain types of personnel training.²⁰²

On 26 February 2024, the Russian government announced an allocation of over RUB 6 billion to assist in retraining workers.²⁰³

On 27 February 2024, the Russian government announced the creation of a tourist route in the occupied territory of Crimea.²⁰⁴

On 28 February 2024, Russia and Iran signed an agreement to cooperate on science and technology in power generation, which includes the digitalization of electrical grids.²⁰⁵

On 15 March 2024, the Russian government allocated RUB 12 billion for the long-term assistance for the elderly.²⁰⁶

On 5 April 2024, the Russian government promised to raise the limits on mortgages for specialists in information technology by RUB 200 billion.²⁰⁷

On 8 April 2024, the Russian government announced the subsidization of housing in the east of the country.²⁰⁸

On 2 of May 2024, the Russian government approved a nine-year investment plan to develop the Baikal-Amur and Trans-Siberian railways.²⁰⁹

On 4 June 2024, the Russian government, alongside the other members of the Eurasian Intergovernmental Council, approved the improvement of transportation infrastructure between the countries on the Council.²¹⁰

On 8 July 2024, Russia vowed to continue expanding its transportation infrastructure, including a high-speed rail.²¹¹

On 15 July 2024, the Russian government promised investment into childcare services for families, healthcare, and education.²¹²

Russia has partially complied with its commitment on the SDGs. It has a clear commitment to addressing the rising importance of digital technology and the digital divides it creates, as well as improving infrastructure. Russia has done little to cooperate with other G20 members to address challenges emerging from the implementation of the 2030 Agenda. Russia has failed to mobilize financing to aid developing countries.

Thus, Russia receives a score of 0.

Saudi Arabia: +1

Saudi Arabia has fully complied with the commitment to take collective action for implementing the G20 2023 Action Plan to Accelerate Progress on the Sustainable Development Goals (SDGs), including its High-Level Principles.

On 4 December 2023, Minister of Economy and Planning, Faisal bin Fadhil participated in a dialogue alongside the President of the New Development Bank Dilma Rousseff at the 2023 United Nations

Climate Change Conference.²¹³ This conversation included ideas on the significance of high-impact investments and how they support innovative solutions to climate change.

On 6 December 2023, the Ministry of Environment, Water and Agriculture attended the Korea International Water Week.²¹⁴ This multilateral conference aimed to focus on the creation of long-term water solutions that are consistent with the SDGs outlined in the United Nations framework. The Ministry consolidated its own commitments to this framework with the Saudi Vision 2030.

On 11 December 2023, Saudi Arabia engaged in the 28th Conference of the Parties to the United Nations Framework Convention on Climate Change in Dubai, United Arab Emirates.²¹⁵ Saudi Arabia engaged with the conference through the construction of the Saudi Green Initiative Pavilion and the Blue Zone pavilion, both which served to encourage dialogue on climate change issues and a carbon-free transition.

On 13 December 2023, Deputy Minister for Policies and Economic Planning Rakan Alsheikh emphasized the Ministry of Economy and Planning's monitoring and evaluation methods during his attendance at the Operational Excellence Conference.²¹⁶ This entailed the Ministry's cooperation to improve Operational Excellence Projects to achieve sustainable economic growth.

On 13 December 2023, Minister of Economy and Planning Faisal Alibrahim participated in the Global Labour Market Conference.²¹⁷ Organized by the Ministry of Human Resources and Social Development, the conference sought to strategize resilience methods for the international labour market, including ideas about sustainable economies.

On 19 December 2023, Minister Alibrahim met with the Under-Secretary-General for Economic and Social Affairs at the United Nations, Li Junhua.²¹⁸ The discourse encompassed international efforts to address global issues and reaffirm the partnership between Saudi Arabia and the United Nations. In addition, the dialogue included strategies to achieve sustainable development goals in consideration of the Saudi Vision 2030.

On 9 January 2024, Vice Minister Ammar Nagadi and Professor Richard Barker of the International Sustainability Standards Board engaged in bilateral discussions.²¹⁹ This discussion included updates on recent Environmental, Social, and Governance developments in Environmental, Social, Governance and improvements to Saudi Arabia's sustainability practices.

On 10 January 2024, Minister Alibrahim engaged in a bilateral meeting with the Director General of the United Nations Industrial Development Organization, Gerd Müller.²²⁰ The dialogue entailed potential investment to promote sustainable industrial development and the clean energy transition.

On 15 January 2024, the Minister of Foreign Affairs, Prince Faisal bin Farhan bin Abdullah, attended the World Economic Forum Annual Meeting.²²¹ This meeting served as a forum for bilateral and multilateral discourse to strategize solutions to global challenges including a session on building sustainability in the Middle East and North Africa.

On 17 January 2024, the Government of Saudi Arabia and the Organisation for Economic Cooperation and Development signed a Memorandum of Understanding regarding cooperation to promote Saudi Arabia's Vision 2030 mission.²²² The agreement encompasses suggestions for cooperation over 19 policy areas entailing ideas for low-carbon transition.

On 18 January 2024, the Ministry of Economy and Planning signed a cooperation agreement with UpLink, an open innovation platform of the World Economic Forum.²²³ The establishment of this bilateral partnership includes two agreements, "Catalyzing Innovation for an Ocean Positive Economy" and "Catalyzing Innovation for a Positive Circular Carbon Economy." These agreements entail the creation of innovation ecosystems to promote solutions to sustainable development challenges.

On 18 January 2024, Minister Alibrahim met with Managing Partner of Copenhagen Infrastructure Partners Jakob Baruël Poulsen at the 2024 World Economic Forum.²²⁴ The meeting entailed conversations regarding collaboration on renewable energy and infrastructure objectives.

On 22 January 2024, the Government of Saudi Arabia hosted the "Universities and the Sustainable Development Goals 2030: Targets and Practices" Conference with the United Nations Institute for

Training and Research.²²⁵ This conference aimed to consolidate global academic institutions and reaffirm strategies for fostering sustainable development through education.

On 20 February 2024, the Saudi Ambassador to the United Kingdom, Bandar bin Sultan bin Abdulaziz, signed an agreement incorporating the Kingdom of Saudi Arabia into the International Coffee Organization.²²⁶ This agreement aims to engage in initiatives that promote productivity, quality and sustainability of coffee-producing countries.

On 29 February 2024, the Minister of Environment, Water and Agriculture, Abdulrahman Abdulmohsen AlFadley, attended the sixth session of the United Nations Environment Assembly in Nairobi, Kenya.²²⁷ During this multilateral session, Minister AlFadley reaffirmed the commitment to sustainable development through international partnerships and an open invitation to important environmental events.

On 29 February 2024, Minister Alibrahim convened with Chief Executive Officer of Global Partnership for Education Laura Frigenti to discuss efforts to transform the education sector in promoting sustainable economic growth.²²⁸

On 4 March 2024, the First International Conference on Sand and Dust Storms was hosted in Riyadh by the Saudi National Center for Meteorology, the World Meteorological Organization and the Sand and Dust Storm Warning Regional Center.²²⁹ This multilateral conference served as a forum for strategic collaboration including a discussion session focused on the development of an international cooperation framework that would align with SDGs.

On 22 March 2024, Chief Executive Officer of the Saudi Fund for Development (SFD) Sultan Abdulrahman Al-Marshad signed two development agreements with the Islamic Republic of Pakistan's Minister of Economic Affairs, Dr. Kazim Niaz.²³⁰The agreements financed USD101 million for hydropower stations, fortifying opportunities for sustainable development.

On 2 April 2024, the Royal Commission for AlUla signed a partnership agreement with the Cultural Heritage Administration of China's Henan Province.²³¹ The partnership aimed to strengthen bilateral information sharing to enhance tourism and sustainable development.

On 15 April 2024, Prince Faisal participated in the Gulf Cooperation Council – Central Asia Strategic Dialogue second ministerial meeting.²³² The meeting aimed to fortify multilateral partnerships to cooperate on strengthening artificial intelligence within a sustainable and circular economy and digitalization.

On 16 April 2024, the SFD signed a development loan agreement with the government of Saint Kitts and Nevis for USD40 million.²³³ The agreement aimed to bolster renewable energy sector in the country by financing the expansion of a power plant project, facilitating the sustainable energy transition.

On 16 April 2024, Minister of Tourism Ahmed bin Aqeel Al-Khateeb led the Saudi Arabian delegation at the UN General Assembly Sustainability Week.²³⁴ This event reaffirmed Saudi Arabia's commitment to SDGs through Minister Al-Khateeb's open invitation to collaborate on the Red Sea Projects.

On 18 April 2024, the SFD signed a USD50 million development loan agreement with Saint Vincent and the Grenadines.²³⁵ The objective of this financing is to enhance sustainability and resilience to improve infrastructure adaptation to climate change effects, reaffirming Saudi Arabia's commitment to sustainable development goals.

On 24 April 2024, Deputy Governor of the Saudi General Authority for Foreign Trade for International Organizations and Agreements Fareed bin Saeed Al-Asaly participated in the second meeting of the Trade and Investment Working Group.²³⁶ The meeting focused on strategizing for sustainable development for women's participation, investment agreements and multilateral trade.

On 27 April 2024, Saudi Arabia as a member of the Islamic Development Bank approved USD418 million to fund new development projects.²³⁷ These projects committed to supporting the SDGs and focus on renewable energy. This funding agreement aimed to provide funding to Tajikistan, Benin, Côte d'Ivoire, and Turkey.

On 28 April 2024, Sultan Al-Marshad of the SFD signed a Memorandum of Understanding with the President of the African Development Bank, Akinwumi Adesina.²³⁸ This agreement promotes bilateral participation in sustainable international development, notably financing of development projects in African developing countries.

On 28 April 2024, the Ministry of Environment, Water and Agriculture declare World Environment Day with the United Nations Environment Programme.²³⁹ This aims to focus attention on sustainable

development to repair desertification and environmental restoration and includes multilateral participation for environmental conservation.

On 28 April 2024, Minister of Commerce Majid bin Abdullah Al-Qasabi, met with Malaysia's Minister of Investment, Trade and Industry Tengku Zafrul Abdul Azisz, Korea's Minister of Trade, Industry and Energy Lee Chang-Yang and Tanzania's Minister of Investment, Industry and Trade Ashatu Kijaji at the World Economic Forum Special Meeting.²⁴⁰ This multilateral meeting included discussions about partnership capacities to enhance sustainable development objectives.

On 30 April 2024, Acting Deputy Minister of Human Resources and Social Development for Social Development Soltan Al-Jurais attended the 11th Asia Pacific Cooperative Ministers Conference.²⁴¹ The conference served as a forum for strengthening multilateral dialogue on "Government-Cooperative Partnership for Cooperative Resilience, Sustainable Development and Inclusive Growth in Asia Pacific & MENA [Middle East and North Africa] Region."

On 30 April 2024, the Advisor to the Ministry of Environment, Water and Agriculture Yousri Matar facilitated the Third Saudi Water Forum 2024.²⁴² This event provided a space for dialogues on the use of artificial intelligence in water conservation to support the SDGs.

On 30 April 2024, the King Salman Humanitarian Aid and Relief Center launched a funding package to the Lives and Livelihoods Fund, organized by the Islamic Development Bank Group.²⁴³ The fund aims to acquire financing required to support sustainable development projects across the member countries.

On 30 April 2024, the Vice Minister of Economy and Planning, Ammar Nagadi, met with the Under Secretary General and Associate Administrator of the United Nations Development Programme, Haoliang Xu.²⁴⁴ This bilateral meeting included dialogues pertaining to international development to support Saudi Arabia's objectives of SDGs.

On 30 April 2024, the Saudi Tourism Investment Company signed an investment agreement with the Tamimi-AWN Alliance company and Royal Commission for Yanbu.²⁴⁵ This public-private partnership aims to bolster Saudi Arabian tourism with a focus on promoting sustainable development and innovation.

On 6 May 2024, the SFD and the United Kingdom's Foreign, Commonwealth and Development Office signed a joint cooperation arrangement.²⁴⁶ This agreement entailed a bilateral commitment to advance development issues and enhance the international development capacity of relevant organizations.

On 7 May 2024, Saudi Arabia and the United Kingdom concluded the Strategic Dialogue on International Development and Humanitarian Assistance.²⁴⁷ This forum opened dialogue regarding the coordination of joint aid delivery to fulfil the SDGs to maximum impact.

On 8 May 2024, Minister AlFadley met the Republic of Senegal's Prime Minister, Othman Sonko.²⁴⁸ This meeting reaffirmed bilateral commitments to supporting further coordination to enhance agricultural and food security development.

On 13 May 2024, Minister AlFadley met with Kenya's Minister of Treated Water and Irrigation during the Tenth World Water Forum.²⁴⁹ This bilateral conversation included strategizing on sustainable water management and water financing.

On 19 May 2024, Minister AlFadley attended the Tenth World Water Forum in Indonesia. During the meeting, he met with Florica Funck, Director General of the Environment Department of the European Union; Amy Khor, Minister of First State for Sustainability and Environment of Singapore; Giuseppe Serra, Deputy Minister of Environmental Transformation and Demographic Challenge in Spain; Saroj Kumar, Director of the Water Sector at the World Bank; and the representative of the Ministry of Infrastructure and Water Management, the Special Envoy for Water in the Dutch government.²⁵⁰

On 22 May 2024, Governor of the Saudi Central Bank Ayman Al-Sayari alongside members of the Saudi Arabian Ministry of Finance attended the Joint Annual Meetings of Arab Financial Institutions.²⁵¹ These discussions aimed to enhance coordination efforts of Arab financial institutions to fortify plans in fulfilling sustainable development goals.

On 23 May 2024, Secretary General of the Digital Cooperation Organization, Deemah AlYahya met with Egypt's Minister of Communications and Information Technology, Dr. Amr Talaat and Secretary General of the Arab League, Ahmed Aboul Gheit.²⁵² This meeting reaffirmed the organization's multilateral commitments to promoting Egypt's digital transformation strategy and promoting Sustainable Development Goals through public-private partnerships.

On 26 May 2024, Minister of Finance Mohammed Bin Abdullah Al-Jadaan attended the third meeting of the G7 Finance Ministers and Central Bank Governors.²⁵³ Minister Al-Jadaan participated in multilateral dialogues on issues of Artificial Intelligence and its use to strengthen sustainable development through equitable financing needs.

On 4 June 2024, the Saudi Delegation led by Governor of the Communications, Space and Technology Commission, Mohammed Saud Al-Tamimi attended the International Telecommunication Union Council.²⁵⁴Their participation aimed to strengthen international cooperation in the information and communication technologies and supporting the digital transition in developing countries.

On 5 June 2024, the Ministry of Environment, Water and Agriculture organized the World Environment Day initiative with the United Nations Environment Programme.²⁵⁵ This aimed to enhance strategies regarding sustainable agricultural systems in the region and the world.

On 6 June 2024, Sultan Al-Marshad o the SFD approved of a development loan agreement with El Salvador's Minister of Finance, Jerson Posada.²⁵⁶ The loan amounting to USD83 million aims to fund water treatment and power generation projects, fulfilling advancement towards SDGs.

On 7 June 2024, Sultan Al-Marshad of the SFD committed the first development loan worth USD103 million with the Vice Minister of Finance and Public Credit of Nicaragua, Bruno Gallardo.²⁵⁷ The agreement aims to support developmental plans and strengthen future sustainable development goals.

On 12 June 2024, Minister AlFadley met with Tajikistan's President, Emomali Rahmon.²⁵⁸ The bilateral dialogues entailed plans to strengthen development initiatives regarding the environmental, water and agricultural industries.

On 26 June 2024, Minister Al-Jadaan attended the Development Forum and Ministerial Council meeting of the Organization of the Petroleum Exporting Countries.²⁵⁹ A tripartite agreement signed by Minister Al-Jadaan, Director-General of the Organization Fund, and Somalia's Minister of Finance, Bihi Iman supporting Somalia's economy recovery. This agreement reaffirmed Saudi Arabia's commitment to the Sustainable Development Goals through the promotion of financial inclusion and accessible financing.

On 26 June 2024, the Saudi Export-Import Bank and the Organization of the Petroleum Exporting Countries Fund signed a memorandum of understanding.²⁶⁰ This agreement aimed to reaffirm commitment to support development initiatives and the introduction of Saudi non-oil exports in mutual markets to promote global sustainable development efforts.

On 28 June 2024, Deputy Governor of the General Authority of Foreign Trade for International Organizations and Agreements, Fareed bin Saeed Al-Asaly participated in the Third Trade and Investment Working Group Meeting.²⁶¹ This meeting allowed for G20 relationships to be strengthened

through dialogue on the G20 framework priorities, including sustainable development in investment agreements and accessible financing.

On 30 June 2024, the Islamic Development Bank approved an allocation of USD368.98 million for development projects in Türkiye, Turkmenistan and Suriname.²⁶² These projects aimed to promote sustainable development with focus on infrastructure, health, education and energy sectors. The investment will be allocated by USDD165 million to Türkiye, USD47.98 million to Suriname and USD156.3 million to Turkmenistan.

On 4 July 2024, the Saudi Contractors Authority participated in the Türkiye-Saudi Arabia Construction Forum.²⁶³ This meeting provided a forum for bilateral dialogue to reaffirm cooperation regarding infrastructural and sustainable development.

On 8 July 2024, the Minister of Economy and Planning, Faisal bin Fadel Alibrahim attended the United Nations High-Level Political Forum on Sustainable Development.²⁶⁴ This multilateral meeting served as a forum to assess international efforts and progress regarding the Sustainable Development Goals under the 2030 Agenda. The Ministry held an event titled "Stimulating Local Efforts for the SDGs" which reaffirmed their commitment to promoting multilateral partnerships.

On 8 July 2024, Minister AlFadley and Governor of the General Authority for Food Security, Ahmed bin Abdulaziz Al-Fares met with Thailand's Minister of Foreign Affairs, Mars Sangiambunsa.²⁶⁵ This meeting reaffirmed cooperative partnerships regarding progress in food security and environmental development and strengthened bilateral commitments to achieving food security and afforestation.

On 11 July 2024, the Saudi Water Authority signed a collaborative agreement with the World Bank.²⁶⁶ This agreement entails documentation of the authority's expertise regarding water development and knowledge-sharing with developing countries to enhance global sustainable development efforts. This will be achieved by utilizing research capacities of the Water Technologies Innovation Institute and Research Advancement.

On 17 July 2024, the Saudi Data and Artificial Intelligence Authority alongside the International Center for Artificial Intelligence Research and Ethics and the United Nations Educational, Scientific and Cultural Organization signed a tripartite agreement.²⁶⁷ This agreement aimed to enhance the center's capacities of promoting global artificial intelligence development by classifying it as a Category II institution under the purview of the United Nations Educational, Scientific and Cultural Organization's (UNESCO).

On 20 July 2024, the King Abdulaziz and his Companions Foundation for Giftedness and Creativity "Mawhiba" and UNESCO Lidia Arthur Brito signed a partnership agreement between Saudi Arabia

and UNESCO.²⁶⁸ The partnership aimed to advance innovation and sustainable development through shared commitments to education throughout Arab countries.

On 22 July 2024, Minister of Economy and Planning, Faisal bin Fadel Alibrahim participated in the G20 Development Ministers' Meeting session titled "Ensuring Access to Water".²⁶⁹ This session reaffirmed multilateral commitments to identifying solutions to scarcity of freshwater resources, sanitation, human development and global health improvement.

On 22 July 2024, Minister of Industry and Mineral Resources, Bandar bin Ibrahim Alkhorayef visited Brazil's Butantan Institute.²⁷⁰ The Butantan Institute focuses on vaccine development and production of pharmaceutical and biopharmaceutical products. Minister Alkhorayef strengthened bilateral public and private partnerships with Brazil and reaffirmed commitments to sustainable development through continued vaccine and pharmaceutical development.

On 5 September 2024, Saudi Ambassador to Tunisia Abdulaziz bin Ali Al-Saqr, Tunisian Minister of Health Mustapha Ferjani, and the SFD Director-General of Operations for Arab Countries Eng. Bandar bin Abdullah Al-Obeid signed a contract to construct and equip the King Salman bin Abdulaziz University Hospital in Tunisia.²⁷¹ The funding totals SAR85 million and will aid to strengthen healthcare infrastructure and bridge the development gap while stimulating economic activity. This funding is another in a long history of soft loans to Tunisia totalling SAR 1.23billion.

On 7 October 2024, Sultan Al-Marshad of the SFD signed a memorandum of cooperation with Dr. Fahad bin Saad Abu Mouti, the Head of the Founding Team of the Global Water Organization.²⁷² This memorandum will focus on establishing a mechanism for international development and cooperation through the financing of water projects worldwide. This will contribute to the sustainable development goals of various countries.

Saudi Arabia has fulfilled its commitments to pursuing the SDGs by engaging through its engagement in multilateralism through partnerships and international conferences. It actively fosters international trade relationships to uphold this commitment, engaging in constant progress to achieve this.

Thus, Saudi Arabia receives a score of +1.

South Africa has actively promoted the SDGs through various national and international forums. The United Nations Sustainable Development Cooperation Framework for South Africa, finalised for 2020-2025, is a crucial example of this commitment. It was developed with multiple stakeholders, aligning national priorities with the broader SDGs.²⁷³

On 12 September 2023, a significant discussion regarding digital transformation occurred during the SDGs Dialogue.²⁷⁴ This event brought together various stakeholders, including government departments, civil society, and the private sector, to discuss strategies for accelerating SDG achievement in South Africa. The dialogue emphasised the need for sustainable development to guide all developmental efforts.

On 10 September 2023, South Africa played a crucial role in advocating for the African Union's membership in the G20.²⁷⁵ This action intended to strengthen global economic governance and ensure that African countries can influence decisions on key issues affecting the continent. This indicates South Africa's efforts to enhance G20 cooperation and partnerships, particularly in representing and advancing the interests of the Global South.

Despite these efforts, there remains a gap in explicitly addressing the mobilisation of affordable and accessible financing and the significant role of tourism and culture as vehicles for achieving the SDGs, as outlined in the Goa Roadmap for Tourism. The available documentation and activities suggest substantial engagement in two of the four required New Delhi Summit commitment components.

South Africa has partially complied with the commitment to take collective action to effectively and timely implement the G20 2023 Action Plan to Accelerate Progress on the SDGs. While South Africa has demonstrated leadership in enhancing cooperation among G20 members and prioritised sustainable development through various national initiatives, further efforts are required to meet all components of the G20 commitment fully.

Thus, South Africa receives a 0.

Türkiye: +1

Türkiye has fully complied with the commitment to take collective action for implementing the G20 2023 Action Plan to Accelerate Progress on the Sustainable Development Goals (SDGs), including its High-Level Principles.

On 3 February 2024, the Minister of National Defense Yasar Guler announced the launch of the serial production contract of the four missile projects initiated in line with the needs of the Turkish Armed Forces (TSK) has been signed.²⁷⁶ He further highlighted that these products will be valuable contributions to the Land Forces, which conduct intense and comprehensive activities, thus helping in combating terrorism in the region.

On 6 February 2024, the Minister of Trade, Omer Bolat, announced on the one-year anniversary of the devastating earthquake that struck mainly south-east of Türkiye a financial support package worth TRL 400 million for small businesses and craftsmen in the earthquake-affected areas of Kahramanmaras, Hatay, Malatya, and Adiyaman.²⁷⁷ In addition to rebuilding efforts in the earthquake-ravaged areas, Halkbank has provided subsidized financing support of TRL 2.2 billion with a 50% interest rate discount to businesses in the region, aiming to revitalize the local economy. Minister Bolat further articulated that the work on export credit and insurance support will continue for exporters in the earthquake-stricken regions. Moreover, renovation activities for around 650,000 heavily and moderately damaged residences are progressing rapidly. Over 200,000 contracts have been awarded to date, with construction advancing swiftly on many of these homes.

On 2 March 2024, President Recep Tayyip Erdoğan visited Antalya to open a hospital with most advanced medical technologies and with a capacity of 1500 beds, thus significantly contributing to the city's development.²⁷⁸ The city hospital system is a new type of healthcare service, representing the government's significant investment in healthcare infrastructure. It aims to improve access to high-quality medical services and overall health outcomes for the population. This translates to a healthier workforce, enhancing development. Moreover, President Erdogan declared that "with the vision of the Turkish Century, we have aimed for greater goals. Our aim is no longer to catch up with developed countries, but to take our place among the leading ones." Additionally, as a tourist city, Antalya is expected to attract even more tourists for medical services as well.

On 21 March 2024, the Turkey Digital Transformation Office announced a new integrated service for compulsory military duties, launched on the e-government gateway, thus increasing efficiency in the process.²⁷⁹ Türkiye's advancements and role in digital transformation can be also demonstrated by the Head of the Higher Education Council, Erol Özvar, announcing plans to implement new artificial intelligence-focused programs in universities for the 2024 and 2025 academic years. Additionally, Türkiye is undertaking significant projects in the realm of digital transformation, such as the deployment of 5G technology and the Türksat 5A and 5B satellites to enhance broadcasting and internet capabilities. Other advancements include the development of smart cities and investments in automation and artificial intelligence. Digital transformation efforts continue to progress in the fields of transportation, healthcare, and infrastructure.²⁸⁰

On 25 March 2024, Minister of Culture and Tourism Mehmet Ersoy announced the dates for the Türkiye Cultural Road Festival 2024.²⁸¹ This festival is designed to celebrate Türkiye's rich cultural heritage and stunning geography. It aims to emphasize the importance of integrating culture, art, and tourism into sustainable growth strategies, showcasing how these elements can work together to drive progress.²⁸² Türkiye's Ministry of Culture and Tourism, in partnership with the United Nations Development Programme and Anadolu Efes, positions tourism as a path to sustainable development

through the "Future is in Tourism Project." Initiatives like the Lavender Scented Village Project, where Türkiye's 93% share of lavender comes from, create local entrepreneurship opportunities, especially for women, thus generating revenue, employment, and increased community involvement.²⁸³ Türkiye aims to increase certified tourism rentals and boost visitor numbers from 56.7 million to 77 million within five years, with an estimated target revenue of reaching 100 billion dollars by 2028 because of this project.

Türkiye has fully complied with its commitment to take collective action for effective and timely implementation of the G20 2023 Action Plan to Accelerate Progress on the SDGs. Türkiye provides credit assistance to families and businesses affected by earthquakes, while rapid infrastructure developments are underway. Additionally, investments in healthcare infrastructure and defense are crucial for inclusive and sustainable development. Investments in the defense sector and technology are crucial for countries such as Türkiye that are strategically located. Thus, fostering the stability of the country through defense serves as the platform for development. Furthermore, research and innovation play integral roles in infrastructure development, healthcare, and defense systems.

Thus, Türkiye receives a score of +1.

United Kingdom: 0

The United Kingdom has partially complied with the commitment to take collective action for implementing the G20 2023 Action Plan to Accelerate Progress on the Sustainable Development Goals (SDGs), including its High-Level Principles.

On 26 January 2024, the UK's Office for National Statistics provided an updated framework for tracking the country's progress on the Sustainable Development Goals.²⁸⁴ This framework includes a comprehensive monitoring and reporting system that is essential for evaluating the UK's ongoing On 15 February 2024, the UK government hosted the "Technology for Climate Action" event at the 26h Conference of the Parties to the United Nations Framework Convention on Climate Change, showcasing how digital and technological advancements are integrated into the government's sustainability efforts. 151 The event highlighted significant contributions from various sectors towards reducing environmental impacts through innovation and sustainable technology practices.

On 7 October 2024, a delegation from the Department of Environment, Food and Rural Affairs arrived in Guatemala 7 to assess the progress of the UK's Biodiverse Landscapes Fund.²⁸⁵ The fund aims to protect biodiversity, reduce poverty while addressing the impacts of climate change while maintaining Guatemalan environmental priorities until 2029. The delegation also shared plans for addressing environmental issues such as the loss of flora and fauna.

The United Kingdom has partially complied with the commitment to take collective action to effectively and timely implement the G20 2023 Action Plan to Accelerate Progress on the SDGs. The UK's structured approach to SDG reporting, its emphasis on integrating sustainability into digital and technology projects, and its participation in international sustainability efforts demonstrate its

commitment. However, a full compliance score cannot be justified without comprehensive evidence addressing all specific components of the New Delhi Summit's commitments.

Thus, the UK receives a score of 0.

United States: +1

The United States has fully complied with its commitment to take collective action for effective and timely implementation of the G20 2023 Action Plan to Accelerate Progress on the Sustainable Development Goals (SDGs), including its High-Level Principles.

On 12 December 2023, the USAID Enterprises for Development, Growth and Empowerment (EDGE) Fund announced USD1.4 million in funding for a new Global Alliance for Trade Facilitation initiative in the Dominican Republic.²⁸⁶ This will empower small- and medium-sized enterprises and women-owned businesses to capitalize on nearshoring opportunities and enhance trade.

On 12 December 2023, the Carnegie Africa Program organized a stocktaking event for the Digital Transformation with Africa (DTA) initiative, launched at the U.S.-Africa Leaders Summit hosted by President Joe Biden in December 2022.²⁸⁷ The review found that DTA had invested USD82 million in year one, with a focus on Digital Economy and Infrastructure, Human Capital Development, and Digital Enabling Environment.

On 22 December 2023, the Pandemic Fund announced a grant envelope of USD500 million for its second round of funding to assist low- and middle-income countries scale up efforts to prepare for future pandemics.²⁸⁸

On 21 February 2024, Secretary of State Antony Blinken attended the G20 Foreign Ministers' Meeting in Rio de Janeiro, Brazil.²⁸⁹ The goal was to enhance cooperation between G20 members and address issues of global concern such as food insecurity, climate change, workers' rights and geopolitical instability.

On 23 February 2024, Secretary Blinken participated in a joint press availability with Argentine Foreign Minister Diana Mondino after meeting in Buenos Aires.²⁹⁰ They discussed issues including economic partnership, Russia's invasion of Ukraine, and improving security in Haiti, thereby enhancing the US-Argentine partnership.

On 6 March 2024, the Women in the Digital Economy Fund (WiDEF) announced the appointment of nine global leaders in digital inclusion to its first Advisory Council. WiDEF, launched by Vice President Kamala Harris in March 2023, is a joint effort between USAID and the Bill and Melinda

Gates Foundation to accelerate progress on closing the gender digital divide. Members represent the private sector, civil society, government, and research communities to inform WiDEF strategy.²⁹¹

On 9 March 2024, the Biden Administration announced its Fiscal Year 2025 Budget proposal, compiling requests for funding to address domestic and global concerns.²⁹² It requested USD 3 billion for strategic climate investments that support bilateral, plurilateral and global programs and initiatives to reduce emissions. It also requested USD250 million for the Partnership for Global Investment and Infrastructure, which aims to mobilize funding to support the infrastructure needs of low- and middle-income countries.

On 10 April 2024, President Joe Biden welcomed Japanese Prime Minister Fumio Kishida for an official visit to the White House in Washington DC.²⁹³ At the summit they reaffirmed their commitment to the US-Japan bilateral partnership, including defence cooperation and private sector-led two-way investment to lead global economic growth.

On 11 April 2024, the Department of State and Airbnb announced its partnership to support binational tourism with a focus on cross-cultural connections and economic opportunity in rural areas. The Department's International Visitor Leadership Program will bring Japanese tourism and hospitality professionals to the United States to collaborate with American peers and study best practices in rural tourism. This program

On 24 April 2024, Acting Special Coordinator for the Partnership for Global Infrastructure and Investment Helaina Matza travelled to Rio de Janeiro, Brazil to advance ongoing efforts to facilitate strategic infrastructure investments in logistics and green transportation, critical minerals supply chains, and accelerate clean energy transformation in agriculture and clean fuel sectors. Acting Special Coordinator Matza met with government officials and private sector partners to discuss potential infrastructure projects and financing opportunities.²⁹⁴

On 8 July, the United Nations Economic and Social Council (ECOSOC) held the High-Level Political Forum on Sustainable Development in New York.²⁹⁵ Jonathan Shrier, US Deputy Representative to ECOSOC, delivered remarks demonstrating its commitments to accelerate progress of the 2030 Agenda, including investments in global food security, global health and private sector investment.²⁹⁶ This indicates the United States' commitment to mobilizing accessible funding for the SDGs.

On 17 July, Secretary Blinken hosted the Americas Partnership for Economic Prosperity (Americas Partnership) Foreign Affairs track Ministerial meeting, bringing together representatives from 11 partner countries. They discussed plans to collaborate on supply chain resiliency, develop sustainable and high-standard infrastructure, improve access to the digital economy, expand entrepreneurship

opportunities, and advance clean energy goals.²⁹⁷ This meeting enhances bilateral relationships within the G20.

On 9 October 2024, Under Secretary for Economic Growth, Energy, and the Environment Jose W. Fernandez travelled to Serbia to meet with President Aleksandar Vučić and other officials in order to advance the Minerals Security Partnership Forum which develops diverse and sustainable critical minerals supply chains while promoting trade and economic opportunities with the United States.²⁹⁸ His visit furthered the relationship between the two countries and highlighted the United States mission to will further develop economic, critical minerals, and energy cooperation in Serbia and throughout Europe.

The United States has fully complied with its commitment to take collective action for effective and timely implementation of the G20 2023 Action Plan to Accelerate Progress on the SDGs. The US has taken action to mobilize financing to support developing countries in socio-economic development, while addressing the role of addressing digital divides through funded initiatives. The US encouraged G20 cooperation by participating in bilateral meetings with member states and reiterating its partnerships.

Thus, the United States receives a score of +1.

European Union: +1

The European Union has fully complied with the commitment to take collective action for implementing the G20 2023 Action Plan to Accelerate Progress on the Sustainable Development Goals (SDGs), including its High-Level Principles.

On 3 December 2023, The European Investment Bank, and eight other multilateral development banks published a joint statement that presented concrete actions to enhance climate outcomes measurement, strengthen country-level collaboration, and increase co-financing and private sector engagement.²⁹⁹ This strong-action plan reaffirms commitments to "socially inclusive, gender responsive and nature positive climate and development action" across the globe.

On 5 December 2023, The European Union and the Government of Belgium announced a EUR25 million funding commitment to the Local Climate Adaptive Living (LoCAL) Facility to fund community-level adaptations to climate-vulnerable countries including Mozambique, Solomon Islands, Uganda and Tanzania.³⁰⁰ This strong action commitment is an inclusive approach to tackling some environmental objectives in the High-Level principles.

On 13 December 2023, the European Commission announced a EUR680 million investment package to fund five flagship projects in the Western Balkans to improve sustainable transportation in Albania

and Montenegro, and clean energy in Albania and Bosnia and Herzegovina.³⁰¹ This strong-action mobilization of finances shows progress towards meeting environmental objectives in the High-Level principles.

On 21 March 2024, representatives from Korea and the European Union held their 20th Joint Committee where they reiterated their commitment to multilateralism, and their cooperation with other G20 members. This less than strong action reaffirms cooperative actions to address the SDGs.

On 25 March 2024, the European Union and departments of the Philippine government unveiled 'The Disaster Risk Reduction Enhancement at the Local Level Technical Assistance' Program, which aims to reinforce local governments in the Philippines, in enhancing their disaster risk reduction and management. ³⁰² The EUR4.28 million contributions by the European Union is a strong action that addresses all three overarching pillars of the commitment.

On 25 April 2024, the European Union Delegation to Indonesia, and Indonesia's Ministry of Investment unveiled the "Attraction Plan for EU Investment in Indonesia" to attract investments in sectors in renewable energy, circular economies, and smart cities. ³⁰³ This strong action plan promotes high-impact investments from both public, and private sectors that can address environmental and economic objectives in Indonesia.

The European Union has fully complied with its commitment to take strong action in each of all three overarching pillars of economic, social and environmental, in line with the High-Level Principles. The European Union's has initiated multiple collaborative policies with other members and international organizations. These policies are both inclusive and collaborative.

Thus, the European Union receives a score of +1.
